AN ORDINANCE AMENDING THE ELECTRICAL CODE OF THE CITY OF CHESTERFIELD TO BE IDENTICAL TO THE CODE OF THE COUNTY OF ST. LOUIS, MISSOURI AS AMENDED DATED NOVEMBER 29, 2005

WHEREAS, the City of Chesterfield on November 21, 1988 entered into an agreement by and between St. Louis County, Missouri and the City of Chesterfield under the provisions of Section 70.21.10 to 70.32.0 inclusive, of the Revised Statutes of the State of Missouri as amended, which empowers municipalities and other political subdivisions to contract and cooperate with each other for common services; and

WHEREAS, the City of Chesterfield has from time to time adopted the St. Louis County Codes as the minimum requirements and standards for construction, alteration, use and occupancy of buildings and structures, the installation of mechanical and plumbing systems, fixtures and equipment to protect the health, safety and welfare of the citizens of the City of Chesterfield; and

WHEREAS, St. Louis County has recently amended its Electrical Code in November 2005; and

WHEREAS, the City of Chesterfield desires to amend its Ordinance to include the newly adopted Code as existing in the St. Louis County.

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHESTERFIELD, ST. LOUIS COUNTY, MISSOURI, AS FOLLOWS:

- Section 1. The St. Louis County Electrical Code as amended by the County of St. Louis, Missouri to the date of last amendatory Ordinances is hereby adopted as the Electrical Code of the City of Chesterfield, Missouri as if fully set out herein, and all previous versions of the aforementioned Codes or conflicting Ordinances are repealed in their entireties. The adopted Ordinance is as follows:
 - 1. Electrical (County Ordinance 22556 Approved November 29, 2005)
- <u>Section 2</u>. The City Administrator of the City of Chesterfield, Missouri is hereby authorized to amend the "SCOPE OF SERVICES" of the existing contractual agreement with the County of St. Louis, Missouri first entered into on November 28, 1988 as amended for code enforcement services pursuant to the revised agreement attached hereto and incorporated herein as if fully set forth herein.
- <u>Section 3</u>. All Ordinance, parts of Ordinances or provisions of the Municipal Code of the City of Chesterfield, Missouri in conflict with any provisions of this Ordinance are hereby repealed.
