AN ORDINANCE AMENDING ORDINANCE NUMBER 35, SCHEDULE IX OF THE ORDINANCES OF THE CITY OF CHESTERFIELD BY AMENDING PROVISIONS THERETO REGARDING THE RESTRICTION OF PARKING ON COUNTRY RIDGE DRIVE, EAGLE POINT COURT, FEDERAL WAY, SYCAMORE HILL COURT AND WILLOW FOREST COURT.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHESTERFIELD, ST. LOUIS COUNTY, MISSOURI, AS FOLLOWS:

Section 1. Ordinance Number 35, Section 3, Schedule IX as it relates to Parking Restrictions is hereby amended by deleting the following:

Section 2. Ordinance Number 35, Section 3, Schedule IX as it relates to Parking Restrictions is hereby amended by adding provisions thereto as follows:

No Parking, 8:00 a.m. to 10:00 a.m., school days

Sycamore Hill Court, both sides

No Parking, 8:00 a.m. to 10:00 a.m., & 2:30 p.m. to 3:30 p.m., school days

Willow Forest Court, both sides

No Parking, 8:00 a.m. to 10:00 a.m., & 2:30 p.m. to 3:30 p.m., school days

Section 3. In all other respects, Ordinance Number 35 is in full force and effect.

Section 4. This ordinance shall be in full force and effect from and after its passage and approval.
