Mission Statement: conservation of native, natural, and energy resources education.

- III. Approval of October 26, 2017, Minutes. First motion was made by Su Ghosh to accept as written and the second by Donna Pecherski. The minutes were unanimously accepted.

- V. Presenter: Fiona Woody, Monsanto's Sustainability & Metrics Lead. Fiona gave an overview of the framework used by Monsanto to measure progress in achieving nine sustainability goals. The United Nations' 2030 Agenda identified 17 sustainability goals. Monsanto contributes to all 17 goals, however, this report focused on the nine goals with the potential to have the greatest impact on our environment. Fiona's supervisor, Dion McBay, also contributed to the conversation. He noted that Monsanto is rated as #12 of the "Greenest Companies" in the world by Newsweek Magazine.
  - A. In regard to Chesterfield specifically points made are noted: In reference to the Purchase of Monsanto by the Bayer Corporation, we were assured that the change will have a positive sustainability impact; Monsanto manages 13 acres of its 117 acres as a wildlife habitat; Monsanto has spent five billion dollars on honeybee health; the Chesterfield Campus has achieved the LEED Gold Certification
  - B. Special Visitor, NWF CWH Partner from '90's' forward; review M/P/P's Chesterfield Metrics: With prior Monsanto Partners we helped them recertify twice with the Wildlife Habitat Council, coordinate household hazardous waste recycling there, and achieve their NWF Business Certification. Monsanto Chesterfield is our 10th Green Team Member listed on our city's website. Evolving Sustainability Team: Lindenwood University, Monsanto/Pfizer, Chesterfield's Boy scouts and Girl Scouts, CCE/NWFCWHTEAM, and two public schools. As a note, Dr. Clarice Hutchins, a partner from the mid 1990's forward was introduced to Fiona Woody and Dion McBay of Monsanto.

- C. Darcy invited Monsanto to have an educational booth at Chesterfield's 27<sup>th</sup> Annual Earth Day, 4/28/18. The idea was well received and the CCE was asked to brainstorm topics we would like Monsanto to have for Earth Day.
- D. Clarice Hutchens was also invited to have an educational booth at Earth Day.
- E. Darcy asked Dion, Fiona and Clarice if their corporations would be willing to financially support the purchase of 20 native bee boxes/nests to be distributed at Earth Day in support of the NWF Native Bees Effort. The CCE will brainstorm and make a proposal to be submitted to all necessary parties. They could be given to our Monarch/Pollinator nexus Gardens honored this past Earth Day.
