- F. Bears, Blankets, cloth sleeves update Darcy, Tom
 - 1. The Older Adults Task Force was asked to help with sewing of the Care Bears. They said NO to this. They will not be able to sew Care Bears. They also need a driver to deliver the Bears and Blankets.
 - 2. 200 more Bears will be coming in 2 weeks.
- G. 26th Annual Earth Day, April 29, 2017, CRITIQUE everyone
 - 1. Cloth sleeves (329) + bag/tag pollinator seeds (110) update. Leftovers will be given out Nov. 4th, or Tom suggested giving them out at the city's concerts and Farmer's Markets.

- 2. CCE Volunteer Tags; **PLAN** (in/outdoors) Libbey, Darcy, Su, Laura.
- 3. Tree Guide. Trees weren't tagged; were watered. Volunteers will need to tag the trees next year. There was discussion on having a sign saying cancelled in the case of lightening. Our advertisements said rain **or** shine. Change to "weather permitting". Ben reported: 40% said they wouldn't pay to have shredding, but they don't shred it there anyway normally. Overall, Ben's survey "on site" shredding would be worthwhile and most would pay a small fee of no more than \$5. Paul noticed that people were fine with NO ONSITE SHREDDING also. There was discussion about leaving it as is, with no onsite shredding. City is looking for a new CONFIDENTIAL DOCUMENT SHREDDER CONTRACTOR, will try to get the city events included in this contract.

 - a: changing time to 9:00 1:00, instead of 2:00.
 - b: being able to set up the night before, with laminated signs.

- d: talk to mall about their recycling bins and people trying to use them. They should be locked or moved for that day.
- e: sending TY note letters to the outside vendors, on the new letterhead, for next year. Make UNIFORM consistent signs for all the outside vendors, and keep them each year.

Drug take back box is located at City Hall 24/7, by the police office. Need measurements from vendors/RE & E numbers. Will have these by next meeting.

Tom suggested other giveaways a possible drawing for plant baskets. Donna suggested having a drawing for recycled products, as we've done in the past.
