1. SITE PLAN COMMITTEE*

- A. <u>Bonhomme Presbyterian Church (Sign Request)</u>: A request for a freestanding monument sign to exceed six (6) feet in height and fifty (50) square feet in outline area for an 8.73 acre tract of land located on the north side of north Outer 40 Rd, west of Timberlake Manor Pkwy, south of Conway Rd, and east of Chesterfield Parkway (18R120333).
- B. <u>Brooking Park Village, Sign Package</u>: A request for a Sign Package to establish sign criteria for the Brooking Park Village development located southwest of the intersection of South Woods Mills Road and Brookings Park Drive.
