## VII. SITE PLANS, BUILDING ELEVATIONS AND SIGNS

- A. **Chesterfield Valley Center Lot 6 (CMS Communications L.L.C.):** An Amended Site Development Section Plan and Landscape Plan for a 2.5 acre tract of land zoned "M-3" Planned Industrial District, located at 722 N. Goddard, 500 ft. north of the intersection of Goddard and Chesterfield Airport Rd.

**Commissioner Broemmer**, representing the Site Plan Committee, made a motion to approve the **Amended Site Development Section Plan and Landscape Plan**. The motion was seconded by Commissioner Schenberg and **passed by a voice vote of 8 to 0**.

- B. **Outdoor Equipment Lot 1 (17585 N. Outer 40 Road):** Amended Site Development Plan, Tree Stand Delineation Plan, Landscape Plan, and Amended Architectural Elevations for 4.018 acre tract of land zoned "PI" Planned Industrial District located east of Boone's Crossing on the north side of North Outer Forty Road.

**Commissioner Broemmer**, representing the Site Plan Committee, made a motion to approve the **Amended Site Development Plan, Tree Stand Delineation Plan, Landscape Plan, and Amended Architectural Elevations**. The motion was seconded by Commissioner Schenberg and **passed by a voice vote of 8 to 0**.

- C. **14477 White Pine Ridge Lane (Nachman Residence):** House addition on the north side of an existing home zoned "R-2" Residence District with a density procedure, located at 14477 White Pine Ridge Lane in the Whitree Subdivision.

**Commissioner Broemmer, representing the Site Plan Committee, made a motion to approve the House Addition.** The motion was seconded by Commissioner Watson and **passed by a voice vote of 8 to 0.**

## VIII. OLD BUSINESS

- A. **P.Z. 43-2007 Chesterfield Industrial Park Lot 8 (The Marten Building):** A request for a change of zoning from "M3" Planned Industrial to "PI" Planned Industrial District for 1.283 acre tract of land located at the southeast corner of Chesterfield Industrial Boulevard and Edison Avenue (17U110167).

Mr. Shawn Seymour, Project Planner, stated the Public Hearing was held on November 15, 2007. At that time one outstanding issue was identified wherein the Petitioner was asked to consider removing some of the uses that are not practical, or which are inconsistent with the surrounding developments. The Petitioner has addressed the issue by letter of November 30, 2007 with the removal of four uses.

**Commissioner Broemmer made a motion to approve P.Z. 43-2007 Chesterfield Industrial Park Lot 8 (The Marten Building).** The motion was seconded by Commissioner Watson.
