Mike, I would like to bring the following recommendation to change the end of the pool season weekly hours forward to the Parks, Recreation and Arts Committee of Council with your approval.

As you are aware, the Chesterfield Family Aquatic Center goes to amended hours when school is back in session the last three weeks of the pool season. Currently the Aquatic Center opens at 4pm Monday – Friday. Staff has analyzed the revenue and expenses for this time frame over the course of four years, (2013, 2014, 2015, 2016).

The Aquatic Center continually loses money each week from the daily admission and concession operations. See Chart below.
