

We have received a request from the trustees of the Clarkson Woods South subdivision to revise the current parking restrictions on several streets within the subdivision. As you know from past requests regarding parking restrictions in this area, students from nearby Marquette High School park along the street during the school day. The request includes verification of the required level of support from the residents, as required by City Policy Statement No. 45.

Please note that the trustees request that some of the signs state "No Parking or Waiting". Evidently, vehicles will pull to the curb and wait to pickup a student from school. We have discussed this matter with Chief Johnson, and he stated that it does not matter if the vehicle is running, and someone is behind the wheel. If the vehicle is stopped within the designated no parking zone, then they would be in violation of the restriction. Therefore, the standard "No Parking" signs will be utilized.



Enclosed are petitions requesting changes in the parking restrictions and the addition of waiting restrictions for three streets in Clarkson Woods South Subdivision:

Country Ridge Drive at Clarkson Road east to White Cedar Court Sycamore Hill Court Willow Forest Court

In the morning and, especially after school, residents are tired of hazardous traffic conditions on subdivision streets across from Marquette High School. Our subdivision has become an extended pickup and parking area for students with as many as 20 cars (sometimes more) lined up on neighborhood streets. In addition, students from Marquette and other schools park in front of subdivision homes with car doors open so that friends who are waiting on neighborhood sidewalks can stay and visit long after school has ended.

The attached petitions are signed by 100% of residents who are affected by these conditions. As you know, getting a 100% response on any issue is difficult, but the residents of Clarkson Woods South are sending a strong message they want the traffic and loitering situation to change. They are requesting that the city replace the existing signs and post the following restrictions:

NO PARKING OR WAITING FROM 8-10 A.M. & 2:30-3:30 P.M. ON SCHOOL DAYS

In addition, trustees are requesting that the signs that have been posted for several years on Federal Way, Eagle Point Court, and

be changed so they are consistent with the new signs posted on Willow Ridge Lane. We would like the existing signs which say "No Parking from 8 -12 noon on School Days be replaced with

AN ORDINANCE AMENDING ORDINANCE NUMBER 35, SCHEDULE IX OF THE ORDINANCES OF THE CITY OF CHESTERFIELD BY AMENDING PROVISIONS THERETO REGARDING THE RESTRICTION OF PARKING ON COUNTRY RIDGE DRIVE, EAGLE POINT COURT, FEDERAL WAY, SYCAMORE HILL COURT AND WILLOW FOREST COURT.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITYOF CHESTERFIELD, ST. LOUIS COUNTY, MISSOURI, AS FOLLOWS:
