Amphitheater Security Cameras





As you are aware, Public Works and Parks Staff have been working with both the Police Department (PD) and Information Technology (IT) staff in an effort to increase security at the amphitheater. For obvious reasons, including both public safety and vandalism, we desire to place security cameras at various locations around the amphitheater. In addition to security, these cameras offer the future ability to stream live video if the City would elect to offer that type of service.

As you are also aware, the PD and IT have previously collaborated to configure the security system within City Hall, as well as several remote camera locations. All of which are recorded and viewable at the PD records clerk stations. As such, rather than create an entirely separate system, we collectively determined that it would be preferable to simply "add to" the existing City system. This system was installed by a local Chesterfield Company, Visionable Surveillance Solutions in 2007. Both the PD and IT staff have developed a working knowledge of the current system. Visionable has been responsive and competitive in managing our system. The existing client/server software has a proven track record, is stable, and the PD and IT Staff have confidence in the system. When the 2007 security upgrade was purchased, Visionable was the lowest and best bidder by approximately \$7,000.

In order to minimize duplication of systems, hardware, software, space, and to simply use existing hardware and software in lieu of purchasing separate equipment; Staff determined it was in our best interest to simply add security cameras at the Amphitheater into the existing security system backbone. These security outputs are then fed wirelessly back to the City Hall system.

We obtained a proposal from Visionable to design and install the necessary equipment at the City's amphitheater. A copy of the proposal is attached. The cost for this equipment and service is \$18,465. The project will be fully funded by proceeds of the Phase Two Park Improvement Financing. It is our collective recommendation that this additional security is warranted. As required by our purchasing procedures, any purchase in excess of \$5,000 for a sole or proprietary source purchase must be approved by City Council. Accordingly, I request that this recommendation be forwarded to the Planning and Public Works Committee for review and recommendation to the full City Council.
