A. <u>Children's Discovery Learning Center</u>: Amended Site Development Plan, Amended Architectural Elevations, Amended Landscape Plan and Architect's Statement for a child care center located at 940 North Woods Mill Road.

Assistant Director of Planning Annissa McCaskill-Clay presented the project which requested an expansion on the existing child care center with substantial changes to the overall architectural elevations. The existing center consists of two (2) separate structures with a covered walkway serving as a connection. The proposed changes by Children's Discovery Learning Center seek to connect the two buildings and create an enclosed foyer at a new entrance. The pole sign located on the site, which is currently located in Missouri Department of Transportation right-of-way, is proposed to be relocated to an island within the parking lot. This location is currently being reviewed for any site distance issues it may cause for the development. The proposed materials are brick and hardy siding to match the exiting development. After review of the project, the staff has no outstanding issues.
