A. P.Z. 02-2010 Spirit Trade Center, Lot 30 (JMD Investments, LLC)

VII. SITE PLANS, BUILDING ELEVATIONS AND SIGNS

A. Mark Andy Industrial Park (Lot B): An Amended Site Development Section Plan, Landscape Plan and Architectural Elevations for a 12.75 acre tract of land zoned "PI" Planned Industrial District located on the north side of Chesterfield Airport Road, one half mile west of the corner of Long Road and Chesterfield Airport Road

<u>Commissioner Nolan</u>, representing the Site Plan Committee, made a motion recommending approval of the Amended Site Development Section Plan, Landscape Plan, and Architectural Elevations for <u>Mark Andy Industrial Park</u> (<u>Lot B</u>). The motion was seconded by <u>Commissioner Geckeler</u> and <u>passed</u> by a voice vote of 7 to 0.

VIII. OLD BUSINESS

A. P.Z. 02-2010 Spirit Trade Center, Lot 30 (JMD Investments, LLC): A request for a change of zoning from a "M3" Planned Industrial District to a "PC" Planned Commercial District for a 1.22 acre tract of land located on the south side of Edison

Avenue, east of the Edison Avenue and Spirit Drive intersection (17V320178).

<u>Project Planner Shawn Seymour</u> stated that the request is to change the zoning in order to add a retail land use to the site – currently *retail* is not a permitted use under the governing ordinance. It was noted that many uses are being removed from this particular site. The three uses being requested are the existing uses of *Office* and *Warehouse*, and the new use of *Retail*.

A Public Hearing was held on March 8, 2010 at which time no issues were raised.

<u>City Attorney Heggie</u> asked whether this site was looking at a bicycle-type use. <u>Mr. Seymour</u> replied that there was a potential tenant for such a use – the *retail* use would cover such an activity.

<u>Commissioner Watson</u> made a motion to approve <u>P.Z. 02-2010 Spirit Trade</u> <u>Center, Lot 30 (JMD Investments, LLC)</u>. The motion was seconded by <u>Commissioner Nolan</u>.
