II. PROJECT PRESENTATIONS:

A. <u>Spirit Valley Business Park Lot 15 (Vermeer)</u>: A Site Development Section Plan, Architectural Elevations, Landscape Plan, Lighting Plan and Architect's Statement of Design for a 6.5 acre parcel located at 621 Spirit Valley East Drive, west of the intersection of Olive Street Road and Chesterfield Airport Road.

Project Planner, Justin Wyse, presented the project request for a new 31,690 square foot building that provides sales and support of new and used environmental and underground equipment, located on a 6.5 acre parcel zoned "PI" Planned Industrial District. Site provides full access on Spirit Valley Central Drive and Spirit Valley East Drive. Site will be accessed on the northern property line and provides shared access on both the northeast and northwest portions of the line. The southern portion of the site is fenced and will be used as a sales/storage lot with east and west gated access. Materials for fence were not submitted. The exterior building materials will be comprised of a conventional steel frame with tilt-up concrete panels. The building will have a metal roof with no rooftop units.
