A request to obtain approval for a Telecommunication Facility Siting Permit in a "PC" Planned Commercial District for a 23.54 acre tract of land located on the north side of Swingly Ridge Drive, west of

Chesterfield Parkway (17S110136).

Summary

At the May 28, 2008, City of Chesterfield Planning Commission meeting, the above-referenced matter was presented for public hearing. As required by City of Chesterfield Ordinance 2391, which governs telecommunications and facilities siting, the Planning Commission shall provide a venue for public hearing only, and shall not provide a recommendation to City Council, but rather provide a list of issues as they see fit.

During the public hearing two issues were raised, that being the height of the proposed telecommunication antenna and if the proposed location of the telecommunication facility on the Double Tree Hotel property was a permitted use. Per ordinance 2391, section 8.(2). the maximum height for a telecommunications tower shall be one hundred and ten (110) feet or no higher than the minimum height necessary to provide reasonable service to be determined by City Council. The applicant has proposed a height of one hundred and forty-seven (147) feet, the height of the Double Tree Hotel. The applicant has also provided a propagation study that visually illustrates the need for the requested height.

On May 19, 2008 the City Council approved ordinance 2458. This ordinance provided approval for a zoning map and ordinance amendment for the Double Tree Hotel property; changing the site zoning district from a "C8" Planned Commercial District to a "PC" Planned Commercial District. The following requirement was included in the amended ordinance,

Broadcasting, transmitting, studios and associated facilities for radios, television and other communications. The only towers permitted on this

site shall be those existing as of May 1, 2008, Ord. 2458 attachment A section I.A.1.(g).

This statement effectively prohibits any new towers to be erected on the Double Tree Hotel property; however it does not prohibit the location of new telecommunication antennas on an existing tower.

The application in question is a request of approval for the co-location of additional telecommunication antennas to be located on the Double Tree Hotel, which in this case acts as the tower. At present time there are two (2) telecommunication companies that utilize the Double Tree Hotel as a tower for the mounting of their antennas.





Description of Property

Parcel 2: A tract of land being adjusted Parcel 1 of the "Boundary adjustment plat of part of lots A and B of Chesterfield Village north plat 1 and part of U.S. Survey 123" a boundary adjustment plat according to the plat thereof recorded in plat book 213, page 23 of the St. Louis County Records, in Township 45 north-range 4 east, St. Louis County, Missouri and being more particularly described as:





ARCHITECTURAL SITE PLAN



Coverage with STL-479-B at 137 ft











Coverage with Chesterfield Sites







Coverage with STL-479-B




Coverage without STL-479-B







Coverage without STL-537-E





Coverage with STL-520-A











Coverage with STL-452-A
