Re: Chesterfield Blue Valley (P.Z. 28-2004 Blue Valley/Agricola Associates): A request for an eighteen (18) month time extension to submit a Site Development Plan for a 55.8 acre-"PC" Planned Commercial District located on the north side of Olive Street Road, approximately .5 miles west of the intersection of Olive Street Road and Chesterfield Airport Road.

Dear Commissioners:

Michael J. Doster, on behalf of the above-referenced project, requests via correspondence dated June 8, 2007 an extension of time to submit a Site Development plan for P.Z. 28-2004 Blue Valley/Agricola Associates. The Department of Planning has reviewed this request and submits the following report:

Background

The subject tract is 55.8 acres and is located on the north side of Olive Street Road, to the west of its intersection with Chesterfield Airport Road. It was zoned to "PC" Planned Commercial by the City of Chesterfield via Ordinance 2236.

Request

As required by City of Chesterfield Ordinance Number 2236, a Site Development Plan is to be submitted for review within eighteen (18) months of the approval of the zoning for the zoning. Where due cause is shown by the developer, ordinance permits the Planning Commission to extend the time for submittal of a plan. Mr. Doster cites "market changes directly affecting the western part of the Valley, in addition to the probability that the Site Development Plan will likely change..." as the reasons for the request. The current deadline to file a plan is August 6, 2007.
