RE: Landmarks Preservation Commission Improvement Grant Application

Request for Ravens-Queathem House

Summary

At the July 10, 2008 meeting of Landmarks Preservation Commission, the Commission voted to approve Mrs. Betty Brandt's request for \$5,000 under the Historic Structure Improvement Grant to assist with improvements that are being made to her property located at 14319 Olive Boulevard known as the Ravens-Queathem House.

The Historic Structure Improvement Grant was established to assist property owners with exterior rehabilitation or repair of structures which are listed on the Chesterfield Historic Register. The Grant is a matching grant program which can provide financial assistance up to \$5,000 over a rolling, consecutive ten (10) year period. The cost of repairs to the Ravens-Queathem House is approximately \$13,692.00. Mrs. Brandt is requesting the maximum award amount of \$5,000.

Alice Fugate of the Landmarks Preservation Committee will be attending the meeting of Planning and Public Works Committee to provide further information on this grant application request. Attached is a letter from Alice Fugate, photos of the subject site and the letter of inquiry from Mrs. Brandt.

Dear Aimee:

I am the owner of the Raven-Queathem House that was placed on the Chesterfield Historic Register on September 15th, 2003.

I have learned about and wish to apply for the \$5.000 matching grant being given by the City of Chesterfield for exterior restoration of historic buildings.

I would use the funds to purchase historically accurate shutters for the exterior windows. The house originally had shutters, but they were removed because of rot. I am enclosing a picture of the house when it had shutters and a cost proposal from a shutter maker. The cost proposal includes priming but not painting. We will have them painted with a historic color.

Due to our short notice of the matching grant program, we have not had enough time to cover all costs. You will see that the cost of the shutters will be over \$10,000. In the event that the number of shutters needed, acquired, or other costs reduce the purchase costs, we will notify the City of any changes.

Thank you for this opportunity to upgrade the historic look of the house. I appreciate the efforts of the City of Chesterfield in this regard.


