SUBJECT: Yield Sign – Village Green Parkway & Clayton Road

As you know, the intersection of Village Green Parkway and Clayton Road was improved as part of the Town & Country Crossing development. The lane configuration for the right turn out of Village Green is now under signal control. Due to this signal control, the existing yield sign on southbound Village Green Parkway sends a conflicting message to motorists. MoDOT has requested that we remove the yield sign.

We have reviewed the intersection, and agree that the sign should be removed. Since this sign is listed in our Traffic Code, the attached ordinance must be approved, which will remove the sign from the code and will authorize staff to remove the sign from the intersection.

Therefore, staff requests the **Planning & Public Works Committee to recommend approval of the attached ordinance which removes the yield sign located on southbound Village Green Parkway at Clayton Road from the Traffic Code, and to forward to City Council for their consideration.**

AN ORDINANCE AMENDING ORDINANCE NUMBER 35, SCHEDULE VII OF THE ORDINANCES OF THE CITY OF CHESTERFIELD BY DELETING A YIELD SIGN AT THE INTERSECTION OF VILLAGE GREEN PARKWAY AND CLAYTON ROAD.

WHEREAS due to the recent improvement to the intersection of Village Green Parkway and Clayton Road, the right turn lane from southbound Village Green Parkway onto Clayton Road is under signal control, therefore, the existing yield sign on southbound Village Green Parkway is no longer necessary; and

WHEREAS the Missouri Department of Transportation has requested the removal of said yield sign so that a conflicting message is not sent to motorists;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHESTERFIELD, ST. LOUIS COUNTY, MISSOURI, AS FOLLOWS:

Section 1. Ordinance Number 35, Section 3, Schedule VII as it relates to Yield Intersections is hereby amended by deleting the provision listed below:

<u>Intersection</u>	<u>Traffic on Highway, Road, Street or Alley listed Below Shall Yield</u>
Village Green Parkway (southbound) and Clayton Road	Village Green Parkway (southbound)

Section 2. In all other respects, Ordinance Number 35 is in full force and effect.

Section 3. This ordinance shall be in full force and effect from and after its passage and approval.
