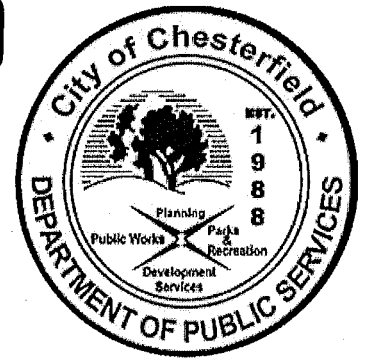

RE: Model Traffic Ordinance – Traffic Schedules

In recent months City Staff has become aware of a number of traffic postings which are not in strict accordance with the City of Chesterfield Model Traffic Ordinance (Appendix C). This can occur for a variety of reasons, which include new construction, change in governmental management (state / county / city), or a change in the name or condition of a roadway (141 / Woods Mill). To ensure the Model Traffic Ordinance reflects exactly what is posted, Public Services Staff has performed a comprehensive review of each of the City's Traffic Schedules. The Traffic Schedules were checked for organization, errors, governmental management, and compliance with current posting. The revised Traffic Schedules are attached for consideration of approval.

Please be advised that there are no changes to road postings being proposed as part of this recommended action. This is simply a housekeeping measure to ensure that our traffic ordinances are as precise as possible and accurately reflect the postings and traffic conditions on our roadways.

Attached is a memorandum from Civil Engineer Chris Krueger which describes the proposed revisions in more detail. This matter has been reviewed by both the Chief of Police and the City Attorney, who both concur with the recommendation.

Action Recommended

This matter should be forwarded to the Planning and Public Works Committee for its consideration of approval of the attached ordinances updating the City of Chesterfield Model Traffic Ordinance. If positively recommended, this matter should be forwarded to City Council for approval.

RE: Schedule I through Schedule XVII Ordinances Revisions

As requested, Schedules I through Schedule XVII within the City of Chesterfield Code of Ordinances were reviewed and revised to reflect current conditions. The City Clerk and Sullivan Publication prefers revisions be completed by repealing and replacing the entire schedule to minimize translation errors or omissions when the Code is updated. Below is a summary of the recommended schedule changes. The recommended action of only repealing a schedule indicates that content was combined with a revised schedule that was not repealed. The proposed ordinances for each schedule are attached.

AN ORDINANCE REPEALING AND REPLACING SCHEDULE I ELECTRIC TRAFFIC CONTROL SIGNALS, OF THE CITY OF CHESTERFIELD CODE OF ORDINANCES.

WHEREAS, the Department of Public Services has completed a comprehensive review of electric traffic signal locations throughout the City; and

WHEREAS, the Department of Public Services has also reviewed the existing Schedule I Electric Traffic Control Signals of the City Code; and

WHEREAS, several signal installations have been completed since the last review of the electric signal location schedule;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHESTERFIELD AS FOLLOWS:

Section 1. Schedule I as it relates to Electric Traffic Control Signals is hereby repealed and replaced with a new Schedule I to read as follows:

AN ORDINANCE REPEALING SCHEDULE II SPEED LIMITS ON STATE HIGHWAYS AND SCHEDULE III SPECIAL SPEED LIMITS ON HIGHWAYS, ROADS OR STREETS, OF THE CITY OF CHESTERFIELD CODE OF ORDINANCES AND COMBINING THE REVISED SCHEDULE II AND III INTO SCHEDULE II, SPEED LIMITS ON HIGHWAYS, ROADS, OR STREETS.

WHEREAS, the Department of Public Services has completed a comprehensive review of speed limits on State, County, and City highways, roads, and streets throughout the City; and

WHEREAS, the Department of Public Services has also reviewed the existing Schedule II Speed Limits on State Highways and Schedule III Special Speed Limits on Highways, Roads or Streets of the City Code; and

WHEREAS, several speed limit changes have occurred since the last review of schedules II and III;

WHEREAS, it is the preference of the Department of Public Services and the Police Department to combine Schedules II and III into one Schedule;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHESTERFIELD AS FOLLOWS:

Section 1. Schedule II and Schedule III are hereby replaced with a new Schedule II Speed Limits on Highways, Roads, or Streets within the City of Chesterfield to read as follows:

In accordance with section 300 of this Code [Code of the City of Chesterfield, Missouri], and when signs are erected giving notice thereof, the maximum speed limits on State, County, and City highways, roads or streets on portions thereon listed in this schedule shall be specified in this schedule.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHESTERFIELD AS FOLLOWS:

Section 1. Schedule XVII as it relates to designated School Zones, is hereby repealed and replaced with a new Schedule XVII to read as follows:

No person shall operate or drive a motor vehicle in a designated school zone at a rate of speed [in excess of twenty miles per hour] 10 miles per hour below the posted speed limit on the highway adjacent to the school zone (but not lower than 20 miles per hour) between 8:00 AM and 4:00 PM on any day when schools are in session and at such other times as shall be designated by the City Traffic Engineer in order to protect children and other persons entering or departing from school premises. Those areas designated as school zones shall be described in Schedule II Speed Limits on Highways, Roads, or Streets adopted by the City of Chesterfield.

Section 2. The previous Schedule XVII, shown below, is deleted:

No person shall operate or drive a motor vehicle in a designated school zone at a rate of speed [in excess of twenty miles per hour] 10 miles per hour below the posted speed limit on the highway adjacent to the school zone (but not lower than 20 miles per hour) between 8:00 AM and 4:00 PM on any day when schools are in session and at such other times as shall be designated by the City Traffic Engineer in order to protect children and other persons entering or departing from school premises. Those areas designated as school zones shall be described in Schedule XVII adopted by the City of Chesterfield.
