2. Parks, Recreation & Arts Issues – Mr. Geisel/Mr. Dunkle

- a. **PRACAC Event Recommendations** Staff requests approval of the PRACAC's preliminary proposals to participate in the 2007 Earth, Tree & Arbor Day event, and to host the 2nd annual September Stroll in 2007. *Committee is requested to review and approve the preliminary proposals as submitted by the PRACAC.*
- b. Change Order CVAC Design Contract Staff requests approval of a change order to the current contract with EDSI for design service associated with the CVAC expansion project. - c. Municipal Parks Grant Round 7 Staff requests approval of a Resolution of Support regarding a grant application for the addition of site coverings at the CVAC. Committee is requested to review and forward recommendation to City Council for the approval of the Resolution of Support for a Municipal Parks Grant to add site coverings at the CVAC.

3. Hog Hollow – Councilmember Durrell, Ward 1

4. West End Stormwater Reservoir – Mr. Geisel

Staff requests approval of a partnership between the City and the Monarch Chesterfield Levee District to construct a stormwater reservoir on the Brasher tract, and also requests approval to enter into a contract with Cole & Associates for the design of a temporary stormwater pumping station. Staff requests approval to attach escrows in the Chesterfield Grove subdivision, in the event the developers do not complete the required improvements. Committee is requested to review and forward recommendation to City Council authorizing Staff to attach the escrows for Chesterfield Grove.
