I wish to make the council aware that since the last meeting on Sep 25, we have not been contacted in any form by the owners nor representatives of the 120 Long Rd property to discuss the possible solution to safety issues of the easement/entrance to our properties.

We see the current path of creating a fire lane to be a nessisary addition to the current property easement arrangement as it stands.

We do not consider the fire lane to be a final solution to the dangers.

Simply marking the pavement and posting signs will in no way make it safe for an "increase" of traffic routed to the site.

The 120 Long Rd property is designed to be used as a quick in and out oil change service facility. It is now being used for larger mechanical repair. The customer cars are now parked for days. Thus the current parking lot and rear easement design is at maximum capacity.

One possible solution is,

The easement will need to be moved to the front of the property and widened to Safely accommodate any further expansion of bays and traffic Such as large trash trucks, tow trucks, employee and customer vehicles and Recreational Vehicles.
