I. CALL TO ORDER

II. PROJECT PRESENTATIONS

A. <u>Chesterfield Presbyterian Church</u>: An Amended Site Plan, Elevations and Architect's Statement of Design for a 12.7 acre tract of land zoned "R1" Residence District, on the north side of Clayton Road and west of the intersection of Clayton Road and Baxter Road, more specifically addressed, 15019 Clayton Road.

Shawn Seymour, Senior Planner, presented the project request to construct an 1,890 square foot addition to an existing 2,500 square foot building located on the easternmost side of the church property. This property is located on the north side of Clayton Road just west of the Clayton and Baxter intersection. The site is 12.7 acres, zoned "R1" Residence District, and the previous site plan was approved in November of 2001. The existing building is utilized for offices and meeting space. The new addition will be utilized for meetings and multipurpose gatherings. The project calls for four additional trees to be planted; one maple, one magnolia and two redbuds with various shrubbery and flowers. The existing structure is comprised of cement board siding and the roof is composed of architectural shingles. The proposed addition will match the existing materials. This addition will not be visible from Clayton Road.
