- **B. NEW BUSINESS**

#### A. Easement - City of Chesterfield

#### STAFF PRESENTATION

Justin Wyse, Director of Planning & Development Services, stated that the developments consisting of Taubman Prestige Outlets of Chesterfield LLC, Plaza Inn LLC, and National Retail Properties LP have all agreed to grant cross-access through each property to the City of Chesterfield. Therefore, Staff is recommending that an Easement be established with the above mentioned grantors for utilization of the access road internally between individual developments for public use. The easement stipulates that each grantor will be solely responsible for any and all costs associated with maintenance and possible replacement of such access road.



#### DISCUSSION

The Committee discussed pedestrian connectivity between Chesterfield Outlets, Residence Inn and Top Golf as well as a sidewalk along North Outer 40 Road. There was also discussion regarding the width of the cross-access roadway.

<u>Councilmember Hurt</u> made a motion to forward the Easement between Taubman Prestige Outlets of Chesterfield LLC, Plaza Inn LLC, National Retail Properties LP and the City of Chesterfield to City Council with a recommendation to approve. The motion was seconded by <u>Councilmember Ohley</u> and <u>passed</u> by a voice vote of 4-0.
