VII. SITE PLANS, BUILDING ELEVATIONS AND PLATS

- A. Chesterfield Commons, Outlot 6 (Buffalo Wild Wings):** Amended Architectural Elevations, Architect's Statement of Design and Light-Emitting Diode (LED) Band for a 1.747 acre lot of land zoned "C8" Planned Commercial District located on the south side of Chesterfield Airport Road, east of the intersection with Boones Crossing.

Commissioner DeGroot, representing the Site Plan Committee, made a motion recommending approval of the Amended Architectural Elevations, Architect's Statement of Design, and Lighting-Emitting Diode (LED) Band for Chesterfield Commons, Outlot 6 (Buffalo Wild Wings). The motion was seconded by Commissioner Geckeler and **passed by a voice vote of 8 to 0.**

VIII. OLD BUSINESS

- A. P.Z. 11-2012 Stages-St. Louis (1023 E Chesterfield Parkway):** A request for a change of zoning from a "C-8" Planned Commercial District to a "PC" Planned Commercial District for a 2.174 acre parcel of land located on the southwest corner of E Chesterfield Parkway and Swingley Ridge Road.

Project Planner Kevin Neill stated that Stages-St. Louis will be moving from its current location near Chesterfield Mall to the subject site. The site requires a change of zoning to allow for the intended uses of *general office, educational facility for specialized private schools, administrative office for religious or educational facility, and indoor theater*. The change of zoning will maintain all other development and procedural requirements currently governing the property.

The Public Hearing for this project was held on October 8, 2012 at which time no issues were raised; however, Staff was still awaiting comments from St. Louis County Department of Highways and Traffic. It was noted that these comments have since been received and were presented at the prior Work Session meeting. Staff recommends approval with the addition of the comments from St. Louis County.

Commissioner Proctor made a motion to approve P.Z. 11-2012 Stages-St. Louis (1023 E Chesterfield Parkway) with the addition of the comments from St. Louis County Department of Highways and Traffic. The motion was seconded by Commissioner DeGroot.
