RE: Public Hearing Signs – City of Chesterfield

Overview

In October 2019 the Planning and Public Works Committee directed City Staff to undergo a review of our current Public Hearing notification process specifically pertaining to the sign posted on the site. This memorandum will discuss our current procedure, include information relative to signs in surrounding municipalities, and contains possible alternatives based on findings.

Current Procedure

The Planner associated with the zoning petition places one (20"x26") sign on every property line that has roadway frontage within reason. The contents of the public hearing sign include the date and time of public hearing, along with the project name and title placed on the Public Hearing agenda. The sign also includes the telephone number to the Department of Planning and Development services, the City's website address, and the City of Chesterfield logo.



The public hearing sign is one of eight ways the City of Chesterfield communicates public hearings. Below is a table outlining the notification requirements for public hearings in the State of Missouri Revisor of Statutes followed by the current notification requirements for public hearings required by the City of Chesterfield.

In the past 5 years, there were on average 17 zoning petitions per year. Although there are 17 individual petitions, the total amount of signs posted varies dependent on the number of parcels embodied in the petition and the number of property lines with frontage that the petition contains. Historically 50 signs are ordered each year. The current cost for a public hearing sign, including print and metal stand, is \$30 paid for by the City. The City uses new signs for every zoning petition as there is site specific information for each sign but typically re-uses the stand multiple times. There is a cost for the publication in the local newspaper, which is reimbursed by the applicant.

Staff Analysis

Date Posted:

One issue raised by the PPW committee was the timing that a public hearing sign is posted in relation to the Public Hearing itself. The current procedure is for City Staff to post signs 15 days before the Public Hearing, which corresponds to the publication date in the local newspaper and the date notices are sent to nearby landowners and subdivision trustees. This is the earliest date that signs can be posted in order to provide information on time, place, and title.

One alternative to explore is to extend the duration of time the sign is posted. The earliest one could post the sign would be as soon as the project meets sufficiency and is assigned to a planner. The duration that the sign would be in public view would vary dependent on the time it takes the applicant to provide all necessary documentation and review before joining a Planning Commission agenda. One positive to be obtained would be that the community traveling past the sign would be informed at the earliest possible date that there is a request. One negative would be that at this time, the request could change dependent on staff's review and the meeting date would be unknown.

Surrounding Municipalities:

Posting of Public Hearing Signs is a common practice among most of the neighboring municipalities. Exhibit 1 embodied in this packet outlines surrounding municipalities' Public Hearing signs. Two approaches are most common. A single-use (site specific) sign that contains site information with time sensitivity, or a standard (universal) sign that is used for all public hearings and has the potential to be made with a more durable material as opposed to a single-use sign.

One important aspect to consider when posting signs in relation to other municipalities is the audience that the sign is intended for. Given the amount of property along major arterial roadways (including highways), the dominant audience would be someone traveling in a vehicle. Also, in many cases, there is not accessible pedestrian infrastructure leading to the sign. Furthermore, the signs are not intended for one to pull over on the side of the road to view but to provide the necessary information as one passes by. Given the city's audience and the amount of information the current sign contains, reducing the amount of text and making the text larger is a logical advancement to be provided in the updated Public Hearing Sign.

Alternatives:

Staff prepared four alternatives for the Planning and Public Works Committee. Alternatives 1 and 2 are site specific signs, while Alternatives 3 and 4 are universal signs. The earliest Alternative 1 is able to post would be 15 days before the Public Hearing matching the city's current process as it contains specific date and time information, while Alternatives 2, 3 and 4 can be posted as soon as the petition reaches sufficiency.
