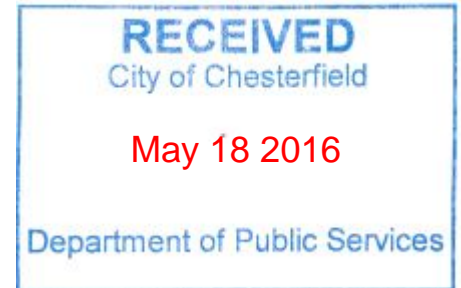

I am Jeff Hawley and I am the president and owner of Block Hawley Commercial Real Estate, a Chesterfield based company. As a specialist in commercial real estate, our company is constantly promoting and selling Chesterfield to local and incoming businesses. We constantly hear these companies talk about how great Chesterfield is, but the conversation ultimately turns to rental housing. The inventory is dated and we are severely underserved by at least 2,000 units.

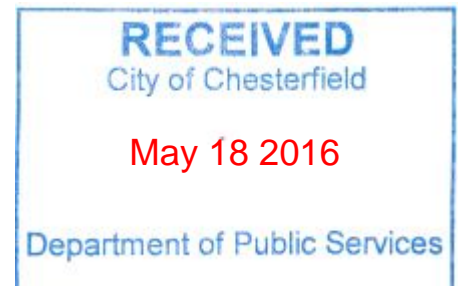
Now, with the addition of RGA, Bunge, Rabo, Merci, and the talk of Monsanto, inventory is tighter than ever. We absolutely need good, high income quality product to meet this demand. If not, we will start to lose the ability to attract new companies and the retailers that support them. Other communities are well ahead of us and this creates a growing problem when our team looks to sell Chesterfield.

As a company, we have been trying to solve this problem for a number of years. Too much of the ground in Chesterfield is overpriced and won't support this development or does not fit into the master plan. Now we have a \$50 million development being proposed along the interstate for a site that meets the master plan. This is exactly the type of development that employers heading down Interstate 64 want to see. We do not want to send the message to the market that we won't address this employer need by modifying this plan. The voice of the business community will be very loud with this.

It is critical that the community find a way to address this shortfall of rental housing. We strongly support this project, particularly the appeal to high income renters, as it is this type product that is in greatest need. Please approve this project and allow for maximum density. My doors remain open to anyone in the room and I encourage you to contact me for further discussion.
