The Public Health and Safety (PH&S) Committee met on Thursday, August 1, 2019. Those in attendance included Chairperson Mary Monachella Councilmember Ward I, Councilmember Ben Keathley, Ward II, Councilmember Michael Moore, Ward III, Councilmember Michael Ohley, Ward IV, Councilmember Dan Hurt, Ward III, City Administrator Mike Geisel, Captain Michael Thompson, Captain Cheryl Funkhouser, and Captain Dan Dunn.

Called to order

The meeting was called to order at 6:00 PM by Chairperson, Councilmember Mary Monachella.

- II. Roll Call was completed
- III. Approval of Minutes March 6, 2010

Councilmember Moore motioned and Councilmember Ohley seconded to approve the minutes of the March 6, 2019 meeting. The motion carried 3-0 with Mary Monachella abstaining.

IV. Election of Vice Chair and Council Liaison to the Police Personnel Board

Councilmember Monachella motioned and Councilmember Keathley seconded to appoint Councilmember Moore Vice-Chairperson of the Public Health & Safety Committee. The motion carried 3-1 with Councilmember Ohley voting "No".

Councilmember Keathley motioned and Councilmember Moore seconded to appoint Councilmember Monachella as Liaison to the Police Personnel Board. The motion carried 3-1 with Councilmember Ohley voting "No".

V. Deer Culling Proposal

Captain Thompson addressed the Committee reviewing the Deer Culling Proposal that was directed by this Committee. Captain Thompson noted that, according to the 2019 deer count, the deer population in the City of Chesterfield has not increased since the 2018 deer count. Captain Thompson has spoken with Ms. Erin Shank, the State's urban wildlife biologist who indicated the City's current bow hunting process is sufficient.

In response to concerns about the deer population within the City of Chesterfield, a proposal was submitted that would expand the current bow hunting policy. This will open specific City owned properties (specifically, Railroad Park, Rivers Edge Park, West

Wetlands, Wilson Park, a small portion of Central Park, and designated locations within the Riparian Trail to bow hunting. The hunters shall be City of Chesterfield employees or elected official unless specifically authorized by the Chief of Police. Specific dates and times will be set for hunting.

All hunters participating in this program will be required to have a valid deer tag and adhere to all regulations as prescribed by the Missouri Department of Conservation. The City of Chesterfield will pay for the cost of processing donated deer.

After discussion, Councilmember Moore motioned and Councilmember Keathley seconded to approve bow hunting in selected City properties following the rules and regulations set by the Missouri Department of Conservation and the proposed policy as set forth by City Staff. The motion carried 3-1 with Councilmember Ohley voting "No".

### VI. Municipal Court - Deferral/Municipal Drug Court Program

The Committee reviewed a report from the City of Chesterfield Prosecuting Attorney, Tim Engelmeyer regarding a newly formed Municipal drug court program. The program began June 1, 2019 and has currently acted on twelve cases to date.

Mr. Engelmeyer outlined the system process and noted limitations because of staff and current resources. He is reaching to other sources, such as private therapists, to donate time to assist with this program. Mr. Engelmeyer noted that he may be seeking financial assistance from the City in the future to continue this worthwhile program.

Councilmember Keathley voiced his opinion that any assistance would be better addressed by the Finance and Administration Committee. He also suggested that Asset Forfeiture Funds may be a source of financial assistance to this program.

The Committee discussed the possibility of a victims advocate system, as it would be related to the Drug Court Program. This will be further discussed as the program grows.

Also included in Mr. Engelmeyer's report was an update on the State mandated Municipal Court computer reporting system. At this time, the "Show Me Courts" computer system is up and running since June 1, 2019. The old system will be converted by September 1, 2019. A Court fee on each case is funding this system.

The Committee members accepted this report as informational and items covered may be considered in the future.

VII. There was no other business brought forward for the Committee to address.

### VIII. Next Meeting

There was no date set for the next meeting.

### IX. Adjournment

Having no further business, Chairperson Monachella adjourned the meeting at 6:35 PM.

RE: Consideration for Additional Code Enforcement Inspector

Sir:

The purpose of this memorandum is to request consideration for the addition of one (1) Code Enforcement Inspector position to the Police Department staff.

The City of Chesterfield, with a population of nearly 50,000 residents and 19,000 households, currently employs one (1) Code Enforcement Inspector who is responsible for handling the numerous daily inquiries from residents, business owners and elected officials and the nearly 500 public nuisance related complaints received each year. These complaints, which have been increasing by nearly 5% per year for the last several years, include issues related to the maintenance of residential and commercial structures, the maintenance of lawns and landscaping, derelict vehicles, and trash can violations, to name a few. By comparison, the City of Florissant, with a population of just over 51,000 residents and 20,000 households, employs three (3) Code Enforcement Inspectors. The City of Wentzville, with a population of just over 41,000 residents and 12,000 households, employs three (3) Code Enforcement Inspectors (one for each Ward) and one part-time seasonal Inspector.

It is important to note that City policy dictates that all nuisance complaints filed with the City will be reviewed and investigated by the Code Enforcement Inspector. In doing so, the City seeks to resolve these complaints through compliance, as opposed to punitive court actions. As a result, the Code Enforcement Inspector spends a considerable amount of time and effort communicating and working with the violator in an effort to abate the nuisance. Oftentimes, the Code Enforcement Inspector is instrumental in mediating and resolving neighborhood strife and discord that have been lingering for years, allowing for improved relations within our community.

Although the efforts of the Inspector results in compliance in the vast majority of reported complaints, the time it takes to achieve these results prevents the ability to proactively address known problem properties or to conduct regular inspections of repeat offenders or vacant homes. The addition of another Code Enforcement Inspector would allow the City to develop a more proactive approach to nuisance related complaints while at the same time thoroughly addressing the formal complaints submitted to the City. In addition, a second Code Enforcement Inspector would allow for uninterrupted and an increased level of service to the residents and business owners within the City. Therefore, I am requesting consideration for adding one (1) Code Enforcement Inspector to the Police Department staff effective FY2020. The starting salary for this position is currently \$43,664.00. The anticipated fully-loaded personnel cost for this position would be no greater than \$61,434.80. Existing office space and equipment would be utilized for this new position, resulting in no additional costs. Costs related to uniforms would be absorbed in the department's existing uniform budget.

Hello,

You may recall last spring, you received several communications from East-West Gateway Council of Governments regarding the planning and public input process for the 2020 – 2025 St. Louis Regional Hazard Mitigation Plan. As part of that process, we asked every county, city, and school district within the counties of Jefferson, Franklin, St. Charles, St. Louis and the City of St. Louis, to complete a short questionnaire regarding natural hazard planning in their jurisdiction.

We appreciate the excellent response to the questionnaire and to the public official workshops held around the region! With that input, we were able to complete the DRAFT 2020 – 2025 St. Louis Regional Hazard Mitigation Plan. The draft Plan is now available for review and public comment until September 30, 2019 at <a href="https://www.ewgateway.org/hazardupdate">www.ewgateway.org/hazardupdate</a>.

The Federal Emergency Management Agency (FEMA) requires that the governing body of your community adopt this Hazard Mitigation Plan by resolution in order to be eligible to apply for state and federal grant funds

for pre-disaster hazard mitigation during the 2020 - 2025 time period. Now that the draft Plan is complete, it is important that your jurisdiction adopt the Plan by resolution this fall. East-West Gateway cannot submit the Plan for final approval until at least 10 percent of our cities and school districts adopt the new Plan.

Please note, the version of the Plan your city will be adopting is the final St. Louis Regional Hazard Mitigation Plan that will be approved by FEMA. If your city adopted the prior, 2015 - 2020 Plan, you will still need to adopt this new plan in order to remain eligible to apply for pre-disaster mitigation funding. Adopting the plan allows your community to apply for funding for projects like flood buyouts, tornado safe rooms, and infrastructure retrofitting.

To make the adoption process as smooth as possible, I've attached a sample resolution for the Plan. The sample resolution is also available for download on the web page above. Once your resolution is approved, please send a signed copy of the resolution back to me (an email scan is great). ## DRAFT 2020-2025 ST. LOUIS REGIONAL HAZARD MITIGATION PLAN AVAILABLE FOR REVIEW

East-West Gateway is working with the city of St. Louis and the Missouri counties of St. Charles, Franklin, Jefferson, and St. Louis to revise and update the <u>St. Louis Regional Hazard Mitigation Plan</u> for the next five years. The draft Plan is now available for public comment and review through September 30, 2019.

The Plan presents information about natural disasters, levels of risk, and strategies for local governments and school districts to take to reduce the adverse effects of natural hazards including tornados, severe thunderstorms, severe winter or summer weather, drought, flood, earthquake, dam failure, or wild fire. The goal of the planning process is to identify the key actions and opportunities for each jurisdiction, but implementation of the plan is voluntary.

Why is the Plan important? Limited federal funding, for projects like flood buyouts and tornado safe rooms, is available to assist communities prepare for some natural disasters, and this funding is only available to communities and school districts that have adopted the plan by resolution passed by their local governing body.

# What is Hazard Mitigation?

The term "mitigation" means to make less harsh or severe. Hazard mitigation activities are actions that can be taken to protect people and property from natural hazards such as floods, severe storms, and extreme temperatures.

# Plan Background

In 2004, EWG developed the first five-year St. Louis Regional Hazard Mitigation Plan in cooperation with the Missouri State Emergency Management Agency (SEMA). There is a different planning process used in Illinois, and each county develops its own plan. The 2004 plan was approved by SEMA and the Federal Emergency Management Agency (FEMA) for the period of 2005-2009. The Plan has since been updated and approved in 2010 (for the years 2010-2015) and 2015 (2015-2020). You can find more information on the most recent plan at the link below:

- 2. Preserve and maintain property, infrastructure, business, and community vitality

- Foster resilient communities that are prepared for natural disasters
- Reduce or avoid losses as a result of natural disasters
- Identify cost effective actions to reduce risk from natural disasters and a strategy to implement those actions
- Focus resources on the greatest risks and vulnerabilities
- Provide a coherent plan as a basis for individual community action
- Build partnerships by involving people, organizations, and businesses
- Increase education and awareness of hazards and risk
- Communicate local priorities to state and federal officials
- Align risk reduction with other community objectives

Following a series of resident complaints received regarding the fireworks display at Logan College last Thursday evening, the matter of how the City regulates these displays has now been placed on the agenda for discussion by PH&S at their scheduled meeting which is set for next Tuesday Sept. 24<sup>th</sup>, 5:30PM.

However, just to keep things in proper perspective, there were a couple inferences in the complaints received by the Mayor and/or council that I would like to address as a point of information for you, prior to that meeting.

First, it was indicated that one complainant had called Chesterfield Police and was referred to St. Louis County Police. However, a review of our taped incoming telephone lines fails to substantiate that assertion. There were approximately 15 calls received by our clerks that evening, and a review of each taped conversation confirms that at no time was any caller referred to St. Louis County Police. In fact, there was no mention of St. Louis County Police in any capacity by any Chesterfield clerk during their conversation(s) with callers that evening.

Secondly, comments were made that "in consideration to the citizens of chesterfield, to see what can be done to stop these displays", characterizing the events as "unfair and inconsiderate to our citizens." The fact is, we as a City, have approved TWO permits thus far in 2019: the City's July Fourth Celebration, and the Chamber of Commerce "end-of-summer concerts" event; both of which, as you know, are long-standing fireworks displays here in the City of Chesterfield. The fireworks display at Logan College this past Thursday was NOT a City approved event and therefore we had no prior knowledge it was to occur.

I appreciate the opportunity to provide this follow-up information. And, If my response here sounds somewhat defensive, I apologize; that is certainly NOT my intent. I simply want to provide you, the Mayor and Council, with the most up to date and correct, verified, information possible. Again, this matter will be discussed further at the upcoming PH&S meeting on Sept. 24<sup>th</sup>. Thanks. RayJ

Mayor.....Members of Council....Mr. Geisel....As you are aware, we (The City) have/has received numerous complaints regarding a fireworks display at Logan College last night; and, I wanted to share with you the info we have on this matter thus far.

First, this was not a City of Chesterfield "approved" fireworks display. Logan College apparently rented out a portion of their facility to the "Chad's Coalition", a mental health related organization that works to prevent Children/Youth suicide. It was billed as "Chad's Illumination Ball", a fund raiser featuring a live auction, musical entertainment and dancing provided by local musicians, and a "special surprise ending" which apparently referred to the fireworks display. We're told that a member of the organization is in the "fireworks business" and provided the display. We are continuing to look into this matter, checking with the Fire District, Logan College Administration, etc., but at this point, it appears no permits were sought, nor issued. I'll advise of additional information as it develops. Thanks.

## FIRE PREVENTION AND PROTECTION

ARTICLE I
In General

Sec. 13-21. Definitions. <sup>2</sup>

As used in this article, unless clearly indicated otherwise, the following terms means:

COMMON FIREWORKS — Explosive devices designed primarily to produce visible or audible effects by combustion, deflagration or detonation. This includes aerial devices containing no more than two (2) grams (one hundred thirty (130) mg) of explosive

composition or ground devices containing no more than fifty (50) mg of explosive composition, all of which are classified as Class C explosives by regulation of the United States Department of Transportation.

FIREWORKS SEASON — The period beginning on the twentieth day of June and continuing through the tenth day of July of the same year and the period beginning on the twentieth day of December and continuing through the second day of January of the next year.

PERSON — Any corporation, association, partnership or individual or group thereof.

SALE — An exchange of articles of fireworks for money, including barter, exchange, gift or offer thereof and each such transaction made by any person, whether as a principal proprietor, salesman, agent, association, copartnership or one or more individuals.

SPECIAL FIREWORKS — Explosive devices designed primarily to produce visible or audible effects by combustion, deflagration or detonation. This term includes devices containing more than two (2) grams (one hundred thirty (130) mg) of explosive composition intended for public display. These devices are classified as Class B explosives by regulation of the United States Department of Transportation.

## Sec. 13-22. Manufacture, sale, shipment unlawful; exception.

### [Ord. No. 88, § 2, 6-1-1988; Ord. No. 686, § 1, 6-15-1992]

- (a) It is unlawful for any person to manufacture, sell, offer for sale, ship or cause to be shipped into the corporate limits of the City of Chesterfield, any item of fireworks. This section applies to nonresidents as well as residents of the City.
- (b) Any person possessing or transporting special fireworks into the corporate limits of the City of Chesterfield for the purpose of conducting a special fireworks display shall be licensed by the state fire marshal as a distributor in accordance with Section 320.126 RSMo. 1985, as amended.
- (c) Before any permit for a special fireworks display shall be issued by the City Administrator, the fair association, amusement park, organization, firm, or corporation making the application therefor shall furnish proof of financial responsibility to satisfy claims for damages to property or personal injuries arising out of any act or omission on the part of such person, firm or corporation or any agent or employee thereof.

### Sec. 13-23. Explosion, ignition, discharge unlawful.

It is unlawful for any person to explode, ignite or discharge any articles of fireworks within the corporate limits of the City.

Sec. 13-24. Penalty for violation.

Violation of this article shall be a misdemeanor punishable by a fine not less than five dollars (\$5.00) and not more than five hundred dollars (\$500.00) or by imprisonment for a period not to exceed three (3) months or by both such fine and imprisonment.

AN ORDINANCE AMENDING CHAPTER 13, SECTION 13-22, OF THE CODE OF THE CITY OF CHESTERPIELD AS IT RELATES TO THE MANUFACTURE, SALE, AND SHIPMENT OF FIREWORKS WITHIN THE CORPORATE LIMITS OF THE CITY OF CHESTERPIELD.

NOW, THEREPORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHESTERFIELD, ST. LOUIS COUNTY, MISSOURI AS FOLLOWS:

<u>Section 1</u>. Section 13-22, "Manufacture, sale, shipment unlawful" of the Code of the City of Chesterfield is hereby deleted in its entirety and replaced with the following provisions:

Section 13-22. Manufacture, sale, shipment unlawful -- Exception.

- (a) It is unlawful for any person to manufacture, sell, offer for sale, ship or cause to be shipped into the corporate limits of the City of Chesterfield, any item of fireworks. This section applies to nonresidents as well as residents of the City.
- (b) Any person possessing or transporting special fireworks into the corporate limits of the City of Chesterfield for the purpose of conducting a special fireworks display shall be licensed by the state fire marshal as a distributor in accordance with §320.126 RSMo. 1985, as amended.
- (c) Before any permit for a special fireworks display shall be issued by the City Administrator, the fair association, amusement park, organization, firm, or corporation making the application therefor shall furnish proof of financial responsibility to satisfy claims for damages to property or personal injuries arising out of any act or omission on the part of such person, firm or corporation or any agent or employee thereof.

Section 2. In all other respects, Chapter 13 of the Code of the City of Chesterfield is in full force and effect.

Section 3. This Ordinance shall be in full force and effect from and after its passage and approval.
