







Chesterfield Citizens Environmental Advisory Committee (CCEAC) June 27, 2024 Summary of Meeting Results City Hall, 690 Chesterfield Parkway West; Room 102-103. 6:00 p.m.

- **I. Call meeting to order –** The meeting was called to order at 6PM by Rob Kilo Vice Chair. Jeanne Tevlin, Chair was on vacation.
- II. Attendance taken and recorded by secretary

III. Discussion/approval of June meeting summary - led by secretary

Motion to approve: Paul made motion to approve minutes with the following changes: under section VIII next meeting is June 27 and under upcoming action dates, deadline for Sixth Mayor's Monarch Pledge, not Fifth. 2nd motion: The motion was seconded by Donna Pecherski

IV. Update on events and deadlines:

a. 6/3 Darcy Capstick emeritus status update. Darcy's emeritus status was approved by City Council. In recognition, a card and cookie cake were given to Darcy.

Agenda topic added per TW Dieckmann:

- a. TW Dieckmann came to our meeting to update us on the Forest Management Plan for Central Park. The goal will be to decrease or eliminate invasives such as IBH, Autumn Olive, etc. Right now, we are not seeing many seedlings grow in this area for reforestation. The Central Park area has been divided into sections. This will be a 4-year process with a couple sections worked on at a time. City can apply for a grant which should cover half the costs of both removal of honeysuckle and replanting. This will be a process of cutting, treating and chipping. There will be opportunities for public participation. This may begin in August of this year. After the invasives have been removed, native grasses will be planted to choke out any residual invasives. There will be no tree planting the first two years to make sure that the invasives have been choked out. TW hopes to hear in July if we receive the grant. Recommendation to start with areas with the highest trail visibility due to significant IBH now choking out trailside pollinators and strong resident interest in removing/reducing invasive species.
- **b.** TW also covered non-CCEAC topics, including a project called Back of House Amphitheater project and a new Central Park Playground project. In October,

TW will know if the Dept. will receive a grant to replace the playground at Central Park.

Return back to CCEAC agenda:

- **b.** 7/5 deadline Chesterfield Citizens newsletter article. The theme of the newsletter is Public Engagement/Conservation. It was decided our articles would stay in line with the theme. A suggestion was the topic that our area zone for planting has changed. We may have an article about what to recycle in the November issue.
- 1. Topic ideas from committee: from Jeanne T benefit of bugs and insects; let's find ways to reduce first, then recycle. Request to send additional topics to Jeanne Tevlin. Su will take the lead on our CCEAC article.
 - c. 8/3 Update on Back-to-School Bash
- 1. Prep work status regarding milk jugs, just rabbits; no holes in bottom; 31 planters stored at Jeanne T, Vaishali took 6 or 7; leave milk labels and cover with large plain labels. Home Depot may donate flowers for the children to plant in the milk jugs. We will meet at Jeanne Tevlin's house again before next meeting date TBD.
 - 2. Work still required: clean markers off, paint pink in ears, and attach labels.
 - 3. Have googly eyes, pink heart stickers for nose (at Jeanne T's)
 - 4. How to do mouth and noses?
 - 5. Status of supplies, potting tools, potting soil, plants, table, markers
 - 6. Plan station layout and how it will work; location?
 - 7. Worker sign up
 - d. Fall Festival scheduled for October 19
- 1. Are we going to participate in the fall festival yes. A motion was made by Paul McCool to participate in the fall festival. It was seconded by Donna Pecherski.
- **e.** Update on City Tree Manual Rob followed up with Arborist Geoff Wegrzyn who said it's still with the Planning Department since April. The city tree manual still has the Callery Pear tree and other inappropriate trees as an 'approved/recommended tree' for planting. We should be concerned that a Developer could plant these invasive trees because it is 'recommended' in the tree manual. Planning and Public Works has information from Jeff Wegrzyn to make changes to the list. Merrell offered to assist in following up on this. This topic should be carried forward for follow up updates at the July CCEAC meeting.

On a separate topic, the Arborist has a list of recommended street trees that are allowed to be selected by residents for a \$100 fee to the city. He will be including an article in the Citizen newsletter.
