MEETING OF THE CITY COUNCIL OF THE CITY OF CHESTERFIELD AT 690 CHESTERFIELD PARKWAY WEST

FEBRUARY 6, 2012

The meeting was called to order at 7 p.m.

Mayor Geiger provided an explanation of the procedures for people wishing to speak at tonight's City Council meeting.

Mayor Bruce Geiger led everyone in the Pledge of Allegiance and followed with a moment of silent prayer.

APPROVAL OF MINUTES

The minutes of the January 18, 2012 City Council meeting were submitted for approval. Councilmember Grissom made a motion, seconded by Councilmember Grier, to approve the City Council minutes. A voice vote was taken with a unanimous affirmative result and the motion was declared passed.

INTRODUCTORY REMARKS

Mayor Geiger presented a Proclamation to Mr. Bob Dierberg, Chairman of Dierbergs, in recognition of the 45th Anniversary of Dierberg's Four Seasons store. Mayor Geiger recognized Sharon Dierberg, wife of Bob Dierberg; Mr. Mike Hanny, Store Director of Dierbergs Four Seasons; and Mr. Jerry Ebest, Vice President of Real Estate for Dierbergs. Mayor Geiger congratulated Dierberg's on this accomplishment.

Mayor Geiger announced that City Hall will be closed Monday, February 20, in observance of the Presidents' Day holiday.

With this in mind, Mayor Geiger announced that the next meeting of City Council has been scheduled for Wednesday, February 22, at 7 p.m.

COMMUNICATIONS AND PETITIONS

Mayor Geiger stated that he asked City Attorney Rob Heggie to give a presentation on the Firearms Ordinance and also asked Prosecuting Attorney Tim Engelmeyer to attend tonight's meeting to answer questions. Mayor Geiger said that the people who support Bill No. 2868 (Proposed amendment regarding the discharge of firearms or projectile weapons) will speak first; people who oppose Bill No. 2868 will speak next, and all others will speak last. After the "Communications" portion of the Agenda is completed, with regard to Bill No. 2868, Mayor Geiger noted that he will ask for a motion to suspend the rules to move to the "Legislation" portion of the Agenda for the final vote on Bill No. 2868.

Mayor Geiger recognized City Attorney Rob Heggie. Mr. Heggie recognized and thanked Prosecuting Attorney Tim Engelmeyer and Chief of Police Ray Johnson for providing insight and helping him draft the firearms ordinance. Mr. Heggie reviewed the Current Ordinance Language Definitions, Actions Prohibited and Exceptions. Mr. Heggie next reviewed the New Ordinance Language Specific Actions Prohibited and Exceptions. He stated that specific language is being added to the City's code, which indicates that nothing in this ordinance is intended to limit anyone's rights under Missouri's "Castle Doctrine." Mr. Heggie next reviewed the provisions and exceptions of firearms ordinances from the following municipalities: Ballwin, Clarkson Valley, Creve Coeur, Kirkwood, Manchester, Maryland Heights, St. Louis City, Town & Country, University City and Webster Groves. Mr. Heggie said there is a defect in the current ordinance that allows someone to use a firearm or projectile weapon to attempt to

protect their homes from squirrels, rodents, birds or small animals. Mr. Heggie said Bill 2868 fixes that defect and is a common sense approach to public safety.

Mayor Geiger stated that public safety is the most important responsibility the City has for its residents. Mayor Geiger said that he, Chief Ray Johnson, and several police officers went to the Police Department's firing range on Thursday, February 2, for a demonstration of shooting a pellet gun, shooting a blow dart gun, and shooting a .22 caliber rifle. The pellet gun was fired into a 3/4" yellow pine board from 30 feet and 60 feet. The blow dart gun was fired into a bullet proof protective vest from 15 feet, 20 feet, 40 feet and 60 feet. The pellet gun and .22 caliber rifle were fired into a tall energy drink can and showed similar entry/exits. Mayor Geiger said this demonstration confirmed that the pellet gun and the blow dart gun are powerful weapons.

Mr. Aaron Goodman, who resides at 14218 Finger Lake Drive in Chesterfield, spoke in support of Bill No. 2868 (Proposed amendment regarding the discharge of firearms or projectile weapons).

Mr. Gary Stein, who resides at 407 Greenstone Drive in Chesterfield, spoke in support of Bill No. 2868 (Proposed amendment regarding the discharge of firearms or projectile weapons). Mr. Stein provided a petition to Mayor Geiger and the Councilmembers, consisting of 133 signatures of residents who support Bill No. 2868.

Ms. Becki Stein, who resides at 407 Greenstone Drive in Chesterfield, spoke in support of Bill No. 2868 (Proposed amendment regarding the discharge of firearms or projectile weapons).

Mr. Robert Weisenfeld, who resides at 412 Greenstone Drive in Chesterfield, spoke in support of Bill No. 2868 (Proposed amendment regarding the discharge of firearms or projectile weapons).

Mr. Harvey Rosenberg, who resides at 217 S. Greentrails Drive in Chesterfield, spoke in support of Bill No. 2868 (Proposed amendment regarding the discharge of firearms or projectile weapons). Mr. Rosenberg apologized for a comment he made at the January 18th City Council meeting when he depicted a resident as being arrogant, selfish, and narcissistic.

Mr. Terry Monachella, who resides at 14164 Trailtop Drive in Chesterfield, spoke in support of Bill No. 2868 (Proposed amendment regarding the discharge of firearms or projectile weapons). Mr. Monachella recited a personal experience about his grandmother being shot in the eye by a BB gun and sustaining permanent injury.

Mr. Greg Hightaian, who resides at 406 Greenstone Drive in Chesterfield, spoke in support of Bill No. 2868 (Proposed amendment regarding the discharge of firearms or projectile weapons).

Mr. Roger Sadler, who resides at 413 Greenstone Drive in Chesterfield, spoke in support of Bill No. 2868 (Proposed amendment regarding the discharge of firearms or projectile weapons).

Mr. David Kaplan, who resides at 14231 Trailtop Drive in Chesterfield, spoke in support of Bill No. 2868 (Proposed amendment regarding the discharge of firearms or projectile weapons).

Mr. Mark Lebedun, who resides at 13536 Ladue Farm, spoke in support of Bill No. 2868 (Proposed amendment regarding the discharge of firearms or projectile weapons). Mr. Lebedun said he had problems with squirrels and paid a refundable \$40 deposit to use a live trap from the Humane Society to re-locate the squirrels.

Ms. Janice Scissors, who resides at 1177 Reelfoot Lake Drive in Chesterfield, spoke in support of Bill No. 2868 (Proposed amendment regarding the discharge of firearms or projectile weapons).

Mr. Mark Perez, who resides at 1655 Garden Valley Court in Wildwood, spoke in opposition to Bill No. 2868 (Proposed amendment regarding the discharge of firearms or projectile weapons).

Mr. Gene Schenberg, who resides at 402 Country Oak Drive in Chesterfield, spoke in opposition to Bill No. 2868 (Proposed amendment regarding the discharge of firearms or projectile weapons). He said that Councilmember Segal had stated at the last Council meeting that the City received ten to fifteen complaints, which is a small percentage of the 48,484 residents in the City. Councilmember Fults said that this issue is not about Mr. Schenberg and his neighbors and that it is not unusual that the City makes laws based upon one situation as the catalyst for the City's decisions. The issue is about protecting all of the City's residents.

Mr. Eric Sowers, who resides at 11 Heathercroft Court in Chesterfield, spoke in opposition to Bill No. 2868 (Proposed amendment regarding the discharge of firearms or projectile weapons). Councilmember Logan said that an injury that occurs to someone as a willing participant in a sport is different than an injury to a resident who is shot by a pellet gun.

Mr. Allan Sheppard, who resides at 826 Judson Manor Drive in Chesterfield, spoke in opposition to Bill No. 2868 (Proposed amendment regarding the discharge of firearms or projectile weapons).

Mr. Stephen Marx, who resides at 2501 N. 14th Street in St. Louis, spoke in opposition to Bill No. 2868 (Proposed amendment regarding the discharge of firearms or projectile weapons).

Mr. Jack Sander, who resides at 1230 Beaver Creek in Chesterfield, spoke in opposition to Bill No. 2868 (Proposed amendment regarding the discharge of firearms or projectile weapons).

Mr. Karl Daubel, who resides at 15022 Willow Lake Court in Chesterfield, spoke in opposition to Bill No. 2868 (Proposed amendment regarding the discharge of firearms or projectile weapons).

Ms. Paula Mogley, who resides at 1507 Mallard Landing Court in Chesterfield, spoke in opposition to Bill No. 2868 (Proposed amendment regarding the discharge of firearms or projectile weapons).

Mr. Robin Harris, who resides at 14570 Bexhill Court in Chesterfield, spoke in opposition to Bill No. 2868 (Proposed amendment regarding the discharge of firearms or projectile weapons). He said he served as a Conservation Agent for almost seven years and feels that he has more experience dealing with problem animals than most people. He discussed different processes to handle animals causing property damage. Councilmember Logan said that this is a public safety issue and that the City is not attempting to eliminate a homeowner's right to rid his premises of problem pests.

Mr. John Schranck, who resides at 5 Ridgetop Drive in Richmond Heights, spoke in opposition to Bill No. 2868 (Proposed amendment regarding the discharge of firearms or projectile weapons).

Mr. Richard Lofftus, who resides at 598 Timber Creek Trail in O'Fallon, Missouri, spoke in opposition to Bill No. 2868 (Proposed amendment regarding the discharge of firearms or projectile weapons). He provided a handout to Mayor Geiger and the Councilmembers, which was a list of the 200 most popular air rifles available in the US.

Mr. Robert Mogley, who resides at 1507 Mallard Landing Court in Chesterfield, spoke in opposition to Bill No. 2868 (Proposed amendment regarding the discharge of firearms or projectile weapons).

Mr. Ed Schoettle, who resides at 618 Kayser Avenue in St. Louis County, spoke in opposition to Bill No. 2868 (Proposed amendment regarding the discharge of firearms or projectile weapons).

Mr. Dave Roland, Director of Litigation for the Freedom Center of Missouri, spoke in opposition to Bill No. 2868 (Proposed amendment regarding the discharge of firearms or projectile weapons). He read, for the record, Missouri Statute Section 21.750, sections 1 and 2:

21.750. 1. The general assembly hereby occupies and preempts the entire field of legislation touching in any way firearms, components, ammunition and supplies to the complete exclusion of any order, ordinance or regulation by any political subdivision of this state. Any existing or future orders, ordinances or regulations

in this field are hereby and shall be null and void except as provided in subsection 3 of this section.

2. No county, city, town, village, municipality, or other political subdivision of this state shall adopt any order, ordinance or regulation concerning in any way the sale, purchase, purchase delay, transfer, ownership, use, keeping, possession, bearing, transportation, licensing, permit, registration, taxation other than sales and compensating use taxes or other controls on firearms, components, ammunition, and supplies except as provided in subsection 3 of this section.

Ms. Tania Pappas, who resides at 15520 Highcroft Drive in Chesterfield, said that, in her opinion, the wording of Bill No. 2868 (Proposed amendment regarding the discharge of firearms or projectile weapons) is causing disagreement. She said no one has mentioned that killing squirrels and birds in one's backyard is hunting, which is not allowed. Councilmember Grissom asked Ms. Pappas, candidate for the office of Councilmember in Ward 2, if she would declare whether she is for or against Bill No. 2868. Ms. Pappas stated, in response, that she would like this matter resolved quickly, one way or the other.

Mayor Geiger said that all the communication on Bill No. 2868 is concluded. Mayor Geiger entertained a motion to suspend the rules to move to the "Legislation" portion of the agenda to address Bill No. 2868 (Proposed amendment regarding the discharge of firearms or projectile weapons). Councilmember Logan made a motion, seconded by Councilmember Grissom, to suspend the rules to address Bill No. 2868 (Proposed amendment regarding the discharge of firearms or projectile weapons). A voice vote was taken with a unanimous affirmative result and the motion was declared passed.

LEGISLATION

BILL NO. 2868 AMENDS SECTIONS 21-103 AND 21-104 OF THE CODE OF ORDINANCES OF THE CITY OF CHESTRFIELD, MISSOURI, RELATING TO THE DISCHARGE OF FIREARMS OR PROJECTILE WEAPONS TO PROTECT CROPS OR OTHER PROPERTY (**FINAL VOTE: PUBLIC HEALTH AND SAFETY COMMITTEE RECOMMENDS APPROVAL; REFLECTS ALL AMENDMENTS APPROVED 1/18/2012**)

Councilmember Flachsbart, Chairperson of the Public Health and Safety Committee, said this is a tough issue. He said he wants to protect residents, but this is really a question of whether the restriction proposed is in contradiction with the Missouri Constitution, which every Councilmember has sworn to uphold. He said that, in his opinion, the Missouri Constitution is very clear on the point that a Missouri resident may use force to protect his/her life, crops, livestock, or property, so any City law that says otherwise would seem to be in contradiction. He said he would like to propose an amendment that he believes will not contradict the Missouri Constitution and would protect the rights.

Councilmember Flachsbart made a motion, seconded by Councilmember Nation, to amend Bill No. 2868, to strike Division 2, Section 21-103, paragraph (i): "It shall be

unlawful to fire or discharge a firearm or a projectile weapon within one hundred fifty (150) yards of a house, dwelling or apartment to protect crops or other property from squirrels, rodents, birds or other small animals” and also strike the last sentence of Section Two, Division 2, Section 21-104: “This exception shall not allow the discharge of a firearm or projectile weapon to protect crops or other property from squirrels, rodents, birds or other small animals” and replace both with the following language: “This exception shall not allow the discharge of a firearm or projectile weapon to protect livestock, crops or other property unless an imminent threat is posed or damage has occurred within the past six months. The mere presence of squirrels, rodents, birds or other animals near livestock, crops or other property while on land, trees, shrubs, ponds, lakes, streams or in air space shall not be construed as an imminent threat. Free passage shall be allowed.” Councilmember Flachsbart said that he received this language in an email from a resident in Ward I. Discussion ensued regarding a person’s rights under the Missouri Constitution and enforcement of Councilmember Flachsbart’s proposed amendment. A roll call vote was taken on the motion to amend Bill No. 2868 with the following results: Ayes – Flachsbart and Nation. Nays – Casey, Logan, Grier, Grissom, Segal and Fults. Whereupon Mayor Geiger declared the motion failed.

A roll call vote was taken for the passage and approval of Bill No. 2868 with the following results: Ayes – Fults, Logan, Grier, Grissom, Segal and Casey. Nays – Flachsbart and Nation. Whereupon Mayor Geiger declared Bill No. 2868 approved, passed it and it became **ORDINANCE NO. 2689**.

TEMPORARY ADJOURNMENT

Mayor Geiger temporarily adjourned the meeting at 9:05 p.m. for those in attendance to take a break. The meeting was reconvened at 9:15 p.m.

Mr. Tom Smallwood, attorney representing Chesterfield Blue Valley, LLC, stated he was available to answer questions on Resolution No. 389 (CID Request for Blue Valley).

Mr. Bud Hirsch, who resides at 17905 Wild Horse Creek Road in Chesterfield, introduced Ms. Nicole Dutton, Associate Director of Chesterfield Arts. Ms. Dutton thanked Mayor Geiger and City Council for their support of Chesterfield Arts and the implementation of the Arts Master Plan. Ms. Dutton announced a project, “The

Inaugural Outdoor Sculpture Competition and Exhibition”, which is designed in accordance with the Arts Master Plan. Ms. Dutton said that Chesterfield Arts is requesting that City Council support this project, both conceptually and financially, with a contribution of \$25,000. Mayor Geiger said this is an exciting project and fully supports it. Mayor Geiger congratulated Chesterfield Arts for their successful “Artfeast” held on February 4th.

APPOINTMENTS

There were no appointments.

COUNCIL COMMITTEE REPORTS

Finance and Administration Committee

Councilmember Michael Casey, Chairperson of the Finance and Administration Committee, made a motion, seconded by Councilmember Flachsbart, to approve the transfer of \$25,000 from the General Fund Fund Reserves to fund Chesterfield Arts for a public art project, “The Inaugural Outdoor Sculpture Competition and Exhibition.” A voice vote was taken with a unanimous affirmative result and the motion was declared passed.

Councilmember Casey next made a motion, seconded by Councilmember Grissom, to approve **Resolution No. 389** (CID Request for Blue Valley), which approves a proposal submitted by Chesterfield Blue Valley for the establishment of a Community Improvement District. Mayor Geiger said this development will have a very positive economic impact on the region and fully supports starting this process. Councilmember Nation said he is pleased with this proposed development but feels he needs more time to study and understand this resolution. City Administrator Mike Herring clarified that Special Legal Counsel Jim Mello explained in tonight’s Agenda Review meeting that the change in Resolution No. 389 is very minor. A voice vote was taken with an affirmative result (7-1 – Councilmember Nation voted “No”) and the motion was declared passed.

Councilmember Casey next reported that AT&T has requested to hold the Telecommunications Siting Permits and that Councilmember Connie Fults will address the AT&T Telecommunications Siting Permits (T.S.P.) in her Planning and Public Works Committee report.

Councilmember Casey announced that the next meeting of this Committee has tentatively been scheduled for Monday, February 27, at 5:30 p.m.

Planning and Public Works Committee

Councilmember Connie Fults, Chairperson of the Planning/Public Works Committee, reported that Bill No. 2872 (Provides for the Acceptance of Streets in the Long Road Crossing Development), Bill No. 2873 (Provides for the Acceptance of Streets in the

Chesterfield Ridge Subdivision), and Bill No. 2874 (Provides for the Acceptance of Streets within and adjacent to Central Park) will be considered for SECOND READING approval and adoption under the “Legislation” portion of the Agenda.

Councilmember Fults next made a motion, seconded by Councilmember Flachsbart, to approve the recommendation from the Chesterfield Historic and Landmark Preservation Committee to award the” Leonard Blake Ancient History Award” to Drs. Michael and Neathery Fuller for their excavation in the City and area, which has aided in the understanding of prehistoric culture . A voice vote was taken with a unanimous affirmative result and the motion was declared passed. [NOTE: Presentation of this award is scheduled for the February 22 City Council meeting.]

Councilmember Fults next made a motion, seconded by Councilmember Casey, to approve the recommendation for the Site Development Plan – Arbors at Wild Horse Creek. A voice vote was taken with a unanimous affirmative result and the motion was declared passed.

Councilmember Fults next made a motion, seconded by Councilmember Flachsbart, to approve the recommendation regarding the City’s participation in Ameren’s “Municipal Tree Replacement Program.” She stated this participation is at no cost to the City. A voice vote was taken with a unanimous affirmative result and the motion was declared passed.

Councilmember Fults next reported that Bill No. 2875 (Approves Parking Restrictions – Clarkson Woods Drive) will be read for the first time under the “Legislation” portion of the Agenda.

Councilmember Fults next made a motion, seconded by Councilmember Casey, to approve **Resolution No. 388** (Adopts City of Chesterfield ADA plan). A voice vote was taken with a unanimous affirmative result and the motion was declared passed.

Councilmember Fults next made a motion, seconded by Councilmember Logan, to hold **TSP 35-2011** – AT&T (14759 Deerhorn Drive), **TSP 36-2011** – AT&T (1972 Baxter Road), **TSP 37-2011** – AT&T (14804 Clayton Road), and **TSP 38-2011** – AT&T (17259 Wild Horse Creek Road) until the April 18, 2012, City Council meeting. She noted that this action is being taken in response to a specific request from AT&T. A voice vote was taken with a unanimous affirmative result and the motion was declared passed.

Councilmember Fults announced that the next meeting of this Committee has been scheduled for Thursday, February 9, at 5:30 p.m.

REPORT FROM THE CITY ADMINISTRATOR

City Administrator Mike Herring reported that Oceano Bistro Chesterfield, 16125 Chesterfield Parkway West, has requested a new liquor license, to sell all kinds of liquor by the drink and Sunday sales. Mr. Herring reported that this application has been

reviewed and recommended for approval by the Departments of Police and Planning/Public Works. Councilmember Casey made a motion, seconded by Councilmember Segal, to approve issuance of a new liquor license to Oceano Bistro Chesterfield. A voice vote was taken with a unanimous affirmative result and the motion was declared passed.

Mr. Herring next reported that The Naked Vine, 1624 Clarkson Road, has requested a new liquor license, to sell all kinds of liquor by the drink. Mr. Herring reported that this application has been reviewed and recommended for approval by the Departments of Police and Planning/Public Works. Councilmember Casey made a motion, seconded by Councilmember Grissom, to approve issuance of a new liquor license to The Naked Vine. A voice vote was taken with a unanimous affirmative result and the motion was declared passed.

Mr. Herring next reported that bids were recently sought for seal-coating the asphalt parking lots at City Hall, Central Park, Dierbergs Meditation Park and the CVAC, as well as a portion of the levee trail. Based upon a review of the information provided by Public Works Director/City Engineer Brian McGownd, Mr. Herring joined with him in recommending award of a contract to McConnell & Associates, in an amount-not-to-exceed \$129,500, for the projects noted above. Adequate funding exists within the FY2012 Budget to cover this entire expense. Councilmember Flachsbart made a motion, seconded by Councilmember Grissom, to award a contract to McConnell & Associates, in an amount not-to-exceed \$129,500. A voice vote was taken with a unanimous affirmative result and the motion was declared passed.

Mr. Herring next reported that proposals were recently sought and then evaluated for engineering design for the Timberlake Manor Bridge Replacement project. Based upon a review of the information provided by Public Works Director/City Engineer Brian McGownd, Mr. Herring joined with him in recommending award of a contract to Juneau Associates, INC., in an amount not-to-exceed \$265,000. \$154,000 of that amount will be reimbursed by grant funds, already obtained. The balance, of \$111,000, is currently budgeted within the Capital Improvement Sales Tax Fund, as part of the local match for this project. Councilmember Flachsbart made a motion, seconded by Councilmember Logan, to award a contract to Juneau Associates, INC., in an amount not-to-exceed \$265,000. A voice vote was taken with a unanimous affirmative result and the motion was declared passed.

Mr. Herring next reported that bids were recently sought for the renovation and reconstruction of the SPLASH PLAYGROUND, at the Family Aquatic Facility. Mr. Herring commended Staff for obtaining grant funding to assist with this construction project, totaling \$90,000, from the Municipal Parks Grant Commission. Based upon a review of the information provided by Director of Planning, Public Works and Parks Mike Geisel, Mr. Herring joined with him in recommending award of a contract to Capri Pool, in an amount-not-to-exceed \$170,000. Approval of this recommendation will require a transfer from the Parks Sales Tax Fund FUND RESERVES, totaling \$80,000. Councilmember Flachsbart made a motion, seconded by Councilmember Grissom, to

award a contract to Capri Pool, in an amount-not-to-exceed \$170,000. A voice vote was taken with a unanimous affirmative result and the motion was declared passed.

NEW BUSINESS

There was no new business.

LEGISLATION

BILL NO. 2872 PERTAINS TO THE ACCEPTANCE OF LONG ROAD CROSSING DRIVE, NORTH SPIRIT DRIVE, NORTH TRADE CENTER BOULEVARD AND NORTH CHESTERFIELD INDUSTRIAL BOULEVARD AS PUBLIC STREETS IN THE CITY OF CHESTERFIELD (**SECOND READING; PLANNING/PUBLIC WORKS COMMITTEE**)

Councilmember Fults made a motion, seconded by Councilmember Casey, for the second reading of Bill No. 2872. A voice vote was taken with a unanimous affirmative result and the motion was declared passed. Bill No. 2872 was read for the second time. A roll call vote was taken for the passage and approval of Bill No. 2872 with the following results: Ayes – Nation, Segal, Grissom, Casey, Logan, Grier, Fults and Flachsbart. Nays – None. Whereupon Mayor Geiger declared Bill No. 2872 approved, passed it and it became **ORDINANCE NO. 2690**.
