### COUNCIL COMMITTEE REPORTS AND ASSOCIATED LEGISLATION

## Planning/Public Works Committee

Councilmember Michelle Ohley, Chairperson of the Planning/Public Works Committee, expressed her appreciation for working with the City's professional staff and specifically Director of Planning and Development Services Justin Wyse during the past year.

Councilmember Ohley announced that the next meeting of this Committee is scheduled for Thursday, April 18, at 5:45 p.m.

### Finance and Administration Committee

Councilmember Barbara McGuinness, Chairperson of the Finance and Administration Committee, indicated that she had no report this evening.

#### Parks, Recreation & Arts Committee

Councilmember Dan Hurt, Chairperson of the Parks, Recreation & Arts Committee, indicated that he had no report this evening.

#### Public Health & Safety Committee

Bill No. 3242 Amends section 21-65 of the City of Chesterfield code of ordinances

dealing with vandalizing public, private and abandoned family cemeteries (First Reading) Public Health & Safety Committee Recommends Approval (Blue Sheet Amendment)

Councilmember Ben Keathley, Chairperson of the Public Health & Safety Committee, made a motion, seconded by Councilmember Mastorakos, for the first reading of Bill No. 3242. A voice vote was taken with a unanimous affirmative result and the motion was declared passed. Bill No. 3242 was read for the first time.

### REPORT FROM THE CITY ADMINISTRATOR

City Administrator Mike Geisel reported that Staff is recommending award of a contract for Bridge Deck Sealing and Epoxy Overlay. Based upon review of information provided by Director of Public Works/City Engineer Jim Eckrich, Mr. Geisel joined with him in recommending authorization for the City Administrator to enter into an agreement with R.V. Wagner Incorporated in an amount not to exceed \$140,000. This project is fully funded by the Capital Projects Fund. Councilmember Ohley made a motion, seconded by Councilmember Flachsbart, to approve this recommendation. A roll call vote was taken with the following results: Ayes – Moore, McGuinness, Ohley, Keathley, Mastorakos, Hurt, DeCampi and Flachsbart. Nays – None. Whereupon Mayor Nation declared the motion passed.

Mr. Geisel reported that Staff is recommending award of a contract for purchase of a replacement brush chipper. Based upon review of information provided by Director of Public Works/City Engineer Jim Eckrich, Mr. Geisel joined with him in recommending authorization for the City Administrator to approve a purchase order to Vermeer Midwest in the amount of \$52,150, net cost after trade-in. This project is fully funded in the 2019 budget. Councilmember Ohley made a motion, seconded by Councilmember Flachsbart, to approve this recommendation. A roll call vote was taken with the following results: Ayes – Flachsbart, Ohley, Mastorakos, Hurt, Keathley, McGuinness, Moore and DeCampi. Nays – None. Whereupon Mayor Nation declared the motion passed.

Mr. Geisel reported that Staff is recommending award of a contract for Sidewalk Replacement Project B. Based upon review of information provided by Director of Public Works/City Engineer Jim Eckrich, Mr. Geisel joined with him in recommending authorization for the City Administrator to enter into an agreement with R.V. Wagner in an amount not to exceed \$276,500, inclusive of the remaining appropriation from the 2018 purchase order with Aztec Construction Specialties. Councilmember Ohley made a motion, seconded by Councilmember Flachsbart, to approve this recommendation. A roll call vote was taken with the following results: Ayes – Mastorakos, DeCampi, Hurt, Flachsbart, Keathley, Ohley, Moore and McGuinness. Nays – None. Whereupon Mayor Nation declared the motion passed.

#### **OTHER LEGISLATION**

Bill No. 3243

Amends City of Chesterfield Ordinance 2682 for a 48.125 acre tract of land located north of North Outer 40 Road and east of Boone's Crossing [P.Z. 01-2019 Chesterfield Outlets (TSG Chesterfield Lifestyle, LLC) 17T420027] (First Reading) Planning Commission recommends approval

Councilmember Ohley made a motion, seconded by Councilmember Hurt, for the first reading of Bill No. 3243. A voice vote was taken with a unanimous affirmative result and the motion was declared passed. Bill No. 3243 was read for the first time.

Mayor Nation declared the motion passed.

Councilmember Hurt was advised that his motion to amend was out of order since the ordinance requires the President Pro-Tem to offer the slate of assignments for Council's consideration and consent.

A roll call vote was taken to approve the slate as presented by President Pro-Tem Moore with the following results: Ayes: Moore, McGuinness, Mastorakos and Flachsbart. Nays – Ohley, DeCampi, Hurt and Keathley. Mayor Nation voted "Aye" to break the tie and declared the motion passed.
