Future projects and long-range goals/priorities

Based on themes developed at Retreat based in three areas: ***New Ideas, Volunteer Programs and Programs***

1. New Ideas for Park Development

- River Access, discussed Boone's Bridge
 - CVAC and Big Muddy (that has a huge breach in the levee)
 - Cindy asked about land that had been for sale. Tom mentioned it was actually for lease rights to hunt
 - The area Cindy was referencing was north of the old bridge. That land is owned by the Corps of Engineers.
 - River's Edge is another possible access point (300 yards from park)
 - bio degradable restroom being installed this year
 - land between park and River's Edge is owned by Corps of Engineers
 - Darcy suggested St. Louis and National Audubon Society may be viable partners - Mitch Leachman is a good resource to contact. Tom said he has other things prior to talking with Mitch
 - Barry asked about access to the right/east of River's Edge and RRP. The floating dock at River's Edge
 - Kimberly mentioned Cindy's thoughts on a boardwalk...being able to enjoy the river with a pier.
 - RRP - 34 acres property to the east is not ours, could be acquired
 - Darcy would like this to be a passive conservation park area. Tom believes there are opportunities to enhance the overall park systems. Track systems for mountain biking and skateboard park opportunity, 9 hole disc golf

- ✓ Smaller pavilions 1-2 tables (ideal for Dierberg's Park)
 - ✓ Medium pavilions 3-6 tables (24-38 people)
 - ✓ Large pavilion 7-10 tables (56-80 people)

Example- Greentrails - 75 people
Pavilion, tables and BBQ - \$30,000
Concrete pad - \$9,843
Restroom - \$90,000
Playground Upgrade - \$175,000
Contingency 10% - \$30,484
Total - \$335,329

Split cost between Parkway and Chesterfield
