BUREAU OF UNIFORMED PATROL

The Bureau of Uniformed Patrol is the largest bureau of the department, consisting of three Lieutenants, six Sergeants and thirty-six Police Officers. These officers provide a visible, uniformed presence within the community, 24 hours per day, 365 days per year. The bureau is responsible for responding to all calls for service; to include crimes in progress, crimes discovered, alarms sounding, traffic crashes and hazards, emotionally disturbed persons, and a myriad of other requests for service. In addition, officers perform preventative patrols of neighborhoods, businesses and parks to detect and deter criminal activity, as well as routinely conducting traffic enforcement to improve traffic safety. Several officers assigned to the bureau are cross trained as Crime Scene Officers whose responsibility is to seize evidence and process crime scenes for forensic evidence. A number of Chesterfield officers have received extensive training to be certified as Crisis Intervention Team officers, which enables them to provide acute and follow-up support to those experiencing a mental health crisis.

LARCENY/ PROPERTY DAMAGE

Chesterfield Ctr.- On 3/20/23 Officers responded to Midwest Bank Centre for an alarm on the ATM. Upon arrival officers observed the ATM attached to a Pickup truck by a large chain. Investigation revealed the truck had been reported stolen on 3/18/2023 from Jennings. Investigation is ongoing.



BUREAU OF UNIFORMED PATROL

PERSON STRUCK	Cambridge Terrace Ct – On $3/22/2023$, officers responded for a call reference a 7-year-old child who had been struck by a vehicle while riding her bicycle. Upon arrival officers observed the vehicle to be on top of the girl. The Officers were able to lift the vehicle off of her and immediately begin CPR until EMS arrived who then began advanced life saving measures. The quick actions of these officers most certainly saved the girl's life.
BURGLARY/ TRESPASSING	Swingley Ridge - On 3/31/2023, officers responded to a call of a trespasser in a secure area of the Dierberg's building on Swingley Ridge. This subject was known to be wanted by Chesterfield PD for burglary due to prior incidents where he entered secure areas of businesses and stole items. The 60-year-old male from St. Louis City was located and arrested. Warrants were obtained for Burglary.
OF NOTE	The Patrol Division took reports for three (3) stolen vehicles and nine (9) thefts from vehicles. Members of the Patrol Division participated in two (2) Major Case Investigations. There were seven (7) instances of vehicles failing to yield.

TRAFFIC ENFORCEMENT UNIT

The Bureau of Traffic Enforcement is responsible for the safety of Chesterfield's residents and visitors as they travel throughout the 244 miles of traffic-ways that wind throughout the 32 square miles of Chesterfield. Additionally, the Unit is charged with coordinating enforcement, safety and security for all special events, such as the annual Independence Day celebration, various runs, and other events held within the City. The Traffic Unit maintains primary responsibility for directed traffic enforcement, accident investigation and special event traffic management throughout the City of Chesterfield.

⇒ The Traffic Enforcement Unit developed a two-hour training course on Missouri Amendment 3 Marijuana Updates and Standardized Field Sobriety Testing which was certified by POST for 2 hours of continuing education credit. The Traffic Bureau conducted this training twice during first quarter in-service training in March.

- ⇒ Traffic Enforcement Unit conducted a DWI saturation patrol on March 17th which led to the arrest of 3 DWI offenders.
- ⇒ Chesterfield Traffic Officers instructed the current class of recruits at the St. Louis County and Municipal Police Academy on RADAR/LASER speed measurement and crash investigation/LETS for a total of 16 hours during the month of March.

Priority Street Enforcement Activity


The Priority Street Traffic Enforcement program identifies numerous streets throughout the City where enhanced enforcement efforts are conducted. These streets are selected based on crash statistics and/or citizen complaints. The majority of these locations are within subdivisions where complaints of speeding and/or stop sign violations have been received. Officers assigned to the Traffic Enforcement Unit and the Bureau of Uniformed Patrol are expected to routinely monitor these locations and take enforcement action when necessary.

ASSAULT (UNFOUNDED)	Officers were called to Chesterfield Mall for an assault that had just occurred. Officers were given specific information for the suspect both via radio and witnesses on scene. A subject was located and detained. It was later determined that no assault had occurred, but rather a disturbance between two special needs individuals. Once this was determined the subject was released to guardians on scene. Officers showed tremendous restraint during a rather stressful situation.
DRUG VIOLATION/ UNLAWFUL USE OF A WEAPON	A FLOCK camera hit led officers to investigate an unoccupied vehicle at the Premium Outlet Mall . The hit indicated the vehicle may be stolen. Once the subjects who had brought the vehicle approached, officers moved in and identified themselves. Both subjects ran, resulting in two different foot pursuits. Both subjects were eventually detained and found to be in possession of 2 firearms, one of them altered so it could fire in "automatic" mode. Also, seized were controlled substances and \$635 in cash.
LARCENY/ SEARCH WARRANT	Officers identified suspects involved in multiple thefts from Market by Macy's . Investigation resulted in the arrest of both subjects and a search warrant for their residence. Search of the residence and seizure from their vehicle used during the thefts resulted in over \$5,000 in recovered property.
OF NOTE	 March saw the opening of baseball / softball season at CVAC. While weather was an issue on some days, the complex was crowded on days when games were played. SEU officers provided a visible police presence on those occasions. SEU officers took 12 theft reports from Walmart and 8 reports from Market by Macy's during the month of February.

CLARKSON VALLEY

On June 1, 2017 the department entered into a contractual agreement with the neighboring City of Clarkson Valley to provide comprehensive police services; 24-hour uniform patrols, traffic enforcement, response to calls for service, court and meeting security and community engagement programs.

BUREAU OF CRIMINAL INVESTIGATIONS

The Bureau of Criminal Investigations is responsible for the follow-up investigation of all active offenses. The Bureau has one detective assigned to all juvenile cases and one detective detached to the St. Louis County Drug Task Force. The Unit is also responsible for major crime scene management, electronic forensic examinations, intelligence information management and personnel background investigations. The Bureau of Criminal Investigations also houses the Crime Suppression Unit which is responsible for the investigation and suppression of varying crime trends.

The Community Affairs Unit is responsible for all crime prevention, police community relations and youth-based programs and initiatives. The unit's programs include Safety Town, COPPS, Code Enforcement, citizen fingerprinting, speaker's bureau, Neighborhood Watch, child car seat installation program, drug take backs and the citizen police academy. The Department's Volunteers in Policing (VIP) program and the Chesterfield Police Explorer Post are also housed within the Community Affairs Unit.

SCHOOL RESOURCE OFFICERS

The School Resource Unit serves as resources and department liaisons at nineteen public and private schools located in Chesterfield and Clarkson Valley. The agency has ten full time officers assigned to the program. Six of the School Resource Officers (SROs) are individually assigned to the three public high schools and three public middle schools located in the two cities. The high school and middle school SRO programs are partially funded by the Parkway School District and the Rockwood School District representing one of the department's many successful community partnerships. In recent years, the department has added four additional officers to the unit that serve a similar role in the City's elementary schools, the Elementary SRO program (ESRO). These ESROs are assigned to seven public and six private elementary schools. Additionally, one ESRO is assigned to Logan College.

As noted in the table below, this unit is able to resolve the vast majority of violations, through voluntary compliance.

- ⇒ On March 25th, The Police Personnel Board conducted the Oral Interview phase of the selection process for 7 police officer candidates. 4 of those candidates successfully completed the interview and were forwarded to the Chief's Office for additional consideration.
- ⇒ Chief Johnson has directed that each of the 4 candidates proceed to psychological evaluations and background investigations.
- ⇒ Two Chesterfield Police Recruits are continuing their basic training at the St. Louis County & Municipal Police Academy and the Jefferson College Police Academy. (Graduation expected in June 2023)




