BUREAU OF UNIFORMED PATROL

The Bureau of Uniformed Patrol is the largest bureau of the department, consisting of three Lieutenants, six Sergeants and thirty-six Police Officers. These officers provide a visible, uniformed presence within the community, 24 hours per day, 365 days per year. The bureau is responsible for responding to all calls for service; to include crimes in progress, crimes discovered, alarms sounding, traffic crashes and hazards, emotionally disturbed persons, and a myriad of other requests for service. In addition, officers perform preventative patrols of neighborhoods, businesses and parks to detect and deter criminal activity, as well as routinely conducting traffic enforcement to improve traffic safety. Several officers assigned to the bureau are cross trained as Crime Scene Officers whose responsibility is to seize evidence and process crime scenes for forensic evidence. A number of Chesterfield officers have received extensive training to be certified as Crisis Intervention Team officers, which enables them to provide acute and follow-up support to those experiencing a mental health crisis.

TRAFFIC ENFORCEMENT UNIT

The Bureau of Traffic Enforcement is responsible for the safety of Chesterfield's residents and visitors as they travel throughout the 244 miles of traffic-ways that wind throughout the 32 square miles of Chesterfield. Additionally, the Unit is charged with coordinating enforcement, safety and security for all special events, such as the annual Independence Day celebration, various runs, and other events held within the City. The Traffic Unit maintains primary responsibility for directed traffic enforcement, accident investigation and special event traffic management throughout the City of Chesterfield.

- ⇒ The Traffic Bureau provided security for ballot collection and escort for the election held on Tuesday, April 4th.
- ⇒ The Bureau of Traffic planned, organized, and staffed the 2023 Chesterfield Chamber of Commerce Blossom Bolt 5k/10k run on Edison Ave. and surrounding roads near the Spirit of St. Louis Airport.
- ⇒ Chesterfield Traffic Officers instructed the current class of recruits on crash investigation/LETS for a total of 20 hours during the month of April.
- ⇒ P.O. Saffa attended the two-week Drug Recognition Expert (DRE) School during the month of April and graduated with a 94% putting her in an elite field of highly trained DWI investigators.
- \Rightarrow Two traffic enforcement officers participated in the Regional "420" Traffic Enforcement Campaign.

Priority Street Enforcement Activity

The Priority Street Traffic Enforcement program identifies numerous streets throughout the City where enhanced enforcement efforts are conducted. These streets are selected based on crash statistics and/or citizen complaints. The majority of these locations are within subdivisions where complaints of speeding and/or stop sign violations have been received. Officers assigned to the Traffic Enforcement Unit and the Bureau of Uniformed Patrol are expected to routinely monitor these locations and take enforcement action when necessary.

TAMPERING/ POSSESSION OF CONTROLLED SUBSTANCE	SEU officers were alerted via FLOCK of a stolen vehicle from St. Louis. Officers located the vehicle and initiated surveillance. When the suspects approached the vehicle, both were apprehended without incident. A search of the vehicle located controlled substances and paraphernalia. Warrants applied for.
LARCENY/ FRADULENT USE OF A CREDIT DEVICE	Investigation found a suspect had stolen cash and credit cards from a victim who had left her purse unattended in a store. The investigating officer was able to identify the subject, arrest her, and obtain a confession. Warrants applied for.
FELONY THEFT	A known suspect who has an extensive theft history, to include numerous incidents in Chesterfield, was identified as the suspect in this case with a theft of approximately \$3,200 in merchandise. Further investigation determined that the same suspect was involved in numerous thefts throughout St. Louis County. The suspect was arrested in Fenton after attempting to elude officers. A warrant was issued for the suspect with a bond of \$50,000.
OVERDOSE	SEU officers responded and assisted with a subject who had overdosed in a hotel. Both SEU officers and patrol officers' actions were instrumental in reviving and stabilizing the subject.
OF NOTE	Calls for service indicating a theft in progress have significantly declined, but the volume of calls for thefts have remained consistent. Most calls that SEU receives are for delayed reports on thefts. Wal- Mart, who usually calls us for thefts in progress, has recently fired one of their lead LP managers. This, along with a potential change in their policy is one of the reasons for the drop-off of in progress calls. Macy's, Ulta, Lowe's, and Home Depot who are targeted regularly for theft only call us after the theft has occurred.

BUREAU OF CRIMINAL INVESTIGATIONS

The Bureau of Criminal Investigations is responsible for the follow-up investigation of all active offenses. The Bureau has one detective assigned to all juvenile cases and one detective detached to the St. Louis County Drug Task Force. The Unit is also responsible for major crime scene management, electronic forensic examinations, intelligence information management and personnel background investigations. The Bureau of Criminal Investigations also houses the Crime Suppression Unit which is responsible for the investigation and suppression of varying crime trends.

The Community Affairs Unit is responsible for all crime prevention, police community relations and youth-based programs and initiatives. The unit's programs include Safety Town, COPPS, Code Enforcement, citizen fingerprinting, speaker's bureau, Neighborhood Watch, child car seat installation program, drug take backs and the citizen police academy. The Department's Volunteers in Policing (VIP) program and the Chesterfield Police Explorer Post are also housed within the Community Affairs Unit.

SCHOOL RESOURCE OFFICERS

The School Resource Unit serves as resources and department liaisons at nineteen public and private schools located in Chesterfield and Clarkson Valley. The agency has ten full time officers assigned to the program. Six of the School Resource Officers (SROs) are individually assigned to the three public high schools and three public middle schools located in the two cities. The high school and middle school SRO programs are partially funded by the Parkway School District and the Rockwood School District representing one of the department's many successful community partnerships. In recent years, the department has added four additional officers to the unit that serve a similar role in the City's elementary schools, the Elementary SRO program (ESRO). These ESROs are assigned to seven public and six private elementary schools. Additionally, one ESRO is assigned to Logan College.

CODE ENFORCEMENT

The Code Enforcement Unit is responsible for responding to complaints of nuisance violations, housing code violation and other quality of life issues that affect members of our community. The department's Code Enforcement Inspector works closely with offending property owners to abate the violation(s); however, legal remedies will be sought when those efforts fail. As noted in the table below, this unit is able to resolve the vast majority of violations, through voluntary compliance.

PERSONNEL


The Personnel Unit directly assists the agency and the Police Personnel Board in the recruitment, hiring, and promotion of police department personnel.

PERSONNEL

- ⇒ On April 17th a directive was issued by the Chief to initiate a Sergeants Promotional Process which will culminate in the promotion of 4 Sergeants. The process will be conducted over the next several months.
- ⇒ Throughout the month of April, the Personnel function administered written tests to 4 applicants.
- ⇒ On April 20th, the Police Personnel Board conducted 3 applicant interviews. Each of these 3 candidates were approved and forwarded for addition consideration.
- ⇒ On April 20th, Chief Johnson hired a finalist who will be assigned as a Recruit to attend the St. Louis County & Municipal Police Academy.
- ⇒ On April 28th, Chief Johnson hired a finalist who currently works at another agency as a full time police officer. This officer will begin Field Training in late May.
