



CHESTERFIELD POLICE DEPARTMENT

BUREAU OF UNIFORMED PATROL

The Bureau of Uniformed Patrol is the largest bureau of the department, consisting of three Lieutenants, six Sergeants and thirty-six Police Officers. These officers provide a visible, uniformed presence within the community, 24 hours per day, 365 days per year. The bureau is responsible for responding to all calls for service; to include crimes in progress, crimes discovered, alarms sounding, traffic crashes and hazards, emotionally disturbed persons, and a myriad of other requests for service. In addition, officers perform preventative patrols of neighborhoods, businesses and parks to detect and deter criminal activity, as well as routinely conducting traffic enforcement to improve traffic safety. Several officers assigned to the bureau are cross trained as Crime Scene Officers whose responsibility is to seize evidence and process crime scenes for forensic evidence. A number of Chesterfield officers have received extensive training to be certified as Crisis Intervention Team officers, which enables them to provide acute and follow-up support to those experiencing a mental health crisis.

STALKING 1ST DEGREE

18XXX Chesterfield Airport Rd- On 09/23/2023A report was generated for a stalking incident. A 52-year-old Imperial resident befriended a juvenile in another venue. Detectives arrested the male who had been repeatedly visiting a juvenile's place of employment, obtained the juvenile's hockey schedule by pretending to be his father, and showed up at his hockey game at Maryville Ice Rink. Interrogation revealed the arrest likely stopped the male from committing sex crimes against the juvenile. St. Louis County Prosecuting Attorney's office charged him with Stalking 1st degree with a \$75,000 cash only bond.

TRAFFICKING IN STOLEN IDENTITIES/ WARRANT ARREST

THF Blvd- On 9/18/2023 Officers responded to a disturbance involving a female chasing a male on foot from a hotel. Officers located and interviewed both subjects. Investigation revealed the 41-year-old male grabbed the female's car keys and took off running on Airport Road. No assault/theft occurred, and the male was arrested for an out-of-county drug warrant. During booking, officers discovered the male was in possession of several stolen identities and he was charged with trafficking in stolen identities. Officers continued follow-up and discovered the subjects didn't pay for their stay at the hotel and were in possession of drug paraphernalia. Warrant application on all charges is pending.

BUREAU OF UNIFORMED PATROL

TAMPERING 1ST DEGREE/FELONY POSSESSION OF STOLEN PROPERTY

Tara Oaks- On 9/8/2023 Officers responded to the 900 block of Tara Oaks at 4:50am for a report of a suspicious individual who was unloading items from one car to another. They observed both vehicles parked near the cul-de-sac. A 42-year-old Springfield resident was found hiding behind a wall at a nearby residence and was taken into custody. Video from the homeowner showed the suspect arrived in the first vehicle, which was stolen from Jefferson County. He parked and began walking through the neighborhood trying to open car door handles. He returned an hour later with the second vehicle which he had just stolen from a nearby neighborhood. The vehicle contained numerous items which were believed to be stolen. The suspect has an extensive criminal history and is currently on probation/parole for stealing motor vehicles (Tampering). Officers contacted his parole officer who placed a detainer on him. Warrants were obtained by our officer for the charge of Tampering 1st with a \$100,000 bond. St. Louis County PD is also getting the charge of Stealing a Motor Vehicle issued for the second stolen auto found with the suspect.

IDENTITY THEFT

Clarkson Rd- On 9/23/2023 Officers responded to Commerce Bank reference a female who was fraudulently attempting to obtain a Home Equity Loan. Officers arrested the 61-year-old New York resident who was in possession of a victim's identification. A warrant application was made, and she was charged with Identity Theft and Attempting to Steal from a Financial Institution. She was given a \$25,000 bond. Officers were contacted by a Commerce Bank investigator who advised that approximately 2 weeks prior the subject was identified as fraudulently stealing over \$11,000 from a victim's account. This case has been forwarded to the Federal Authorities for further investigation.

TRAFFIC ENFORCEMENT UNIT

The Bureau of Traffic Enforcement is responsible for the safety of Chesterfield's residents and visitors as they travel throughout the 244 miles of traffic-ways that wind throughout the 32 square miles of Chesterfield. Additionally, the Unit is charged with coordinating enforcement, safety and security for all special events, such as the annual Independence Day celebration, various runs, and other events held within the City. The Traffic Unit maintains primary responsibility for directed traffic enforcement, accident investigation and special event traffic management throughout the City of Chesterfield.

- ⇒ On Friday, September 1st, members of the Traffic Bureau provided traffic control for 750 citizens attending an outdoor showing of the movie A Bug's Life. The event took place at Faust Park and was sponsored by The Butterfly House.
- ⇒ Two members of the Bureau of Traffic provided roll call training for the new CAD system to four rotations of officers from two squads of the Bureau of Uniformed Patrol.

Priority Street Enforcement Activity

The Priority Street Traffic Enforcement program identifies numerous streets throughout the City where enhanced enforcement efforts are conducted. These streets are selected based on crash statistics and/or citizen complaints. The majority of these locations are within subdivisions where complaints of speeding and/or stop sign violations have been received. Officers assigned to the Traffic Enforcement Unit and the Bureau of Uniformed Patrol are expected to routinely monitor these locations and take enforcement action when necessary.



SPECIAL ENFORCEMENT UNIT

FELONY THEFT

A delayed report from Macy's of a theft of over \$2,000 in merchandise was reported. Investigation identified two suspects, one of them being a juvenile. Investigation also determined that another individual is involved with the two suspects in other cases. The adult suspect turned herself in and admitted to the thefts. Warrant application submitted.

FELONY THEFT

A delayed report from Macy's of a theft of over \$1,500 in merchandise was reported. Investigation identified one of two suspects. That subject was arrested and confessed to her involvement, but refused to identify the other party. Warrant application submitted.

FELONY THEFT

An SEU officer at Premium Outlet was alerted to a theft in progress. A witness had reported seeing an unknown subject dump a large amount of clothing that she had removed from under her clothing into a vehicle and then return to the mall. The witness provided the officer with a detailed description. With that information the officer located the suspect along with another subject involved in the theft and was able to detain them both. Both suspects are known to SEU officers and have been arrested numerous times for theft. During his investigation, the SEU officer recovered nearly \$1,700 in stolen merchandise from six different businesses. One of the suspects admitted to theft, while the other did not issue a statement. Warrants to be applied for.

TAMPERING

A FLOCK hit generated a search for a stolen vehicle in the area of Clarkson and Lea Oak. It was eventually located near Total Wine off of Clarkson Road. As officers approached to contact the driver, the vehicle sped off. Officers did not initiate a pursuit. It was later determined that the subject in the vehicle had left behind a passenger who was on video exiting the stolen car and entering Total Wine. She was located and arrested as she matched the description of a subject who had stolen \$800 worth of alcohol from a total wine in Illinois. She also had 9 warrants from other jurisdictions. The female subject was uncooperative and warrants were refused for her regarding tampering. The stolen vehicle is currently wanted and officers are attempting to identify the driver.

CLARKSON VALLEY

On June 1, 2017 the department entered into a contractual agreement with the neighboring City of Clarkson Valley to provide comprehensive police services; 24-hour uniform patrols, traffic enforcement, response to calls for service, court and meeting security and community engagement programs.

The Bureau has one detective assigned to all juvenile cases and one detective detached to the St. Louis County Drug Task Force. The Unit is also responsible for major crime scene management, electronic forensic examinations, intelligence information management and personnel background investigations. The Bureau of Criminal Investigations also houses the Crime Suppression Unit which is responsible for the investigation and suppression of varying crime trends.

BUREAU OF CRIMINAL INVESTIGATIONS

STALKING 1ST DEGREE

Detective Bureau apprehended, interviewed, and obtained a warrant for Stalking 1st on a subject who repeatedly contacted a juvenile male and falsified his identity to obtain his hockey schedule to go to one of his games in Chesterfield.

VEHICLE THEFT

Detectives assisted with interviewing, obtaining a search warrant, and obtaining an in custody warrant for a subject on Probation/Parole for auto theft who drove a stolen vehicle into the City to steal another vehicle.

FRAUD

Suspect in Facebook fraud traced back to Florida and Sheriff took over investigation as they have multiple open cases on her.

POSSESSION OF A CONTROLLED SUBSTANCE

Suspicious vehicle check resulted in arrest for Possession of Controlled Substance (Meth).

LARCENY

Subject arrested and confessed to stealing a credit card at Main Event and using it at multiple locations. Released Pending Application for Warrant.

COMMUNITY AFFAIRS

The Community Affairs Unit is responsible for all crime prevention, police community relations and youth-based programs and initiatives. The unit's programs include Safety Town, COPPS, Code Enforcement, citizen fingerprinting, speaker's bureau, Neighborhood Watch, child car seat installation program, drug take backs and the citizen police academy. The Department's Volunteers in Policing (VIP) program and the Chesterfield Police Explorer Post are also housed within the Community Affairs Unit.

SCHOOL RESOURCE OFFICERS

The School Resource Unit serves as resources and department liaisons at nineteen public and private schools located in Chesterfield and Clarkson Valley. The agency has ten full time officers assigned to the program. Six of the School Resource Officers (SROs) are individually assigned to the three public high schools and three public middle schools located in the two cities. The high school and middle school SRO programs are partially funded by the Parkway School District and the Rockwood School District representing one of the department's many successful community partnerships. In recent years, the department has added four additional officers to the unit that serve a similar role in the City's elementary schools, the Elementary SRO program (ESRO). These ESROs are assigned to seven public and six private elementary schools. Additionally, one ESRO is assigned to Logan College.
