BUREAU OF UNIFORMED PATROL

The Bureau of Uniformed Patrol is the largest bureau of the department, consisting of three Lieutenants, six Sergeants and thirty-six Police Officers. These officers provide a visible, uniformed presence within the community, 24 hours per day, 365 days per year. The bureau is responsible for responding to all calls for service; to include crimes in progress, crimes discovered, alarms sounding, traffic crashes and hazards, emotionally disturbed persons, and a myriad of other requests for service. In addition, officers perform preventative patrols of neighborhoods, businesses and parks to detect and deter criminal activity, as well as routinely conducting traffic enforcement to improve traffic safety. Several officers assigned to the bureau are cross trained as Crime Scene Officers whose responsibility is to seize evidence and process crime scenes for forensic evidence. A number of Chesterfield officers have received extensive training to be certified as Crisis Intervention Team officers, which enables them to provide acute and follow-up support to those experiencing a mental health crisis.

TRAFFIC ENFORCEMENT UNIT

The Bureau of Traffic Enforcement is responsible for the safety of Chesterfield's residents and visitors as they travel throughout the 244 miles of traffic-ways that wind throughout the 32 square miles of Chesterfield. Additionally, the Unit is charged with coordinating enforcement, safety and security for all special events, such as the annual Independence Day celebration, various runs, and other events held within the City. The Traffic Unit maintains primary responsibility for directed traffic enforcement, accident investigation and special event traffic management throughout the City of Chesterfield.

Priority Street Enforcement Activity

The Priority Street Traffic Enforcement program identifies numerous streets throughout the City where enhanced enforcement efforts are conducted. These streets are selected based on crash statistics and/or citizen complaints. The majority of these locations are within subdivisions where complaints of speeding and/or stop sign violations have been received. Officers assigned to the Traffic Enforcement Unit and the Bureau of Uniformed Patrol are expected to routinely monitor these locations and take enforcement action when necessary.


SPECIAL ENFORCEMENT UNIT

STEALING FELONY	SEU officers received a call from Ulta reporting the theft of approximately \$5,000 in product over two days by an adult and a juvenile. Investigation led to the identification of the adult, and the officer learned that it was common practice of the adult to use her children to assist her in stealing from stores. The investigating officer was able to locate the suspect, arrest her, and obtain a full confession. An in-custody warrant application resulted in 2 warrants being issued on the subject along with a \$100,000 bond.
SUICIDAL	The summent contingent of SELL officient and also members of the
SUBJECT/CIT	The current contingent of SEU officers are also members of the department Special Response Team (SRT). As members, the three officers responded along with patrol officers for a report of a subject armed with a working flame thrower who was expressing suicidal ideations. The SEU officers assisted with setting up a perimeter with both lethal and less-lethal weapon options. One of the officers contacted the subject via phone and developed an on-going rapport with the subject. The subject eventually surrendered, with no injuries to any party.
STEALING	A call for a suspicious person at Old Navy resulted in the arrest of a subject who had stolen over \$600 in merchandise and abandoned another \$200 in merchandise once she noticed officers were approaching. Subject was arrested and cited for the theft.
STEALING FELONY	SEU officers received a call for a theft of several (5) iPads and a Chrome book from a learning center in Chesterfield Mall. Three subjects were initially detained until it was learned that just one subject was involved. The subject admitted to the theft and produced the stolen items, which were returned to the learning center. The subject was arrested and warrant application was made.

Crimes/Incidents Reported

BUREAU OF CRIMINAL INVESTIGATIONS

The Bureau of Criminal Investigations is responsible for the follow-up investigation of all active offenses. The Bureau has one detective assigned to all juvenile cases and one detective detached to the St. Louis County Drug Task Force. The Unit is also responsible for major crime scene management, electronic forensic examinations, intelligence information management and personnel background investigations. The Bureau of Criminal Investigations also houses the Crime Suppression Unit which is responsible for the investigation and suppression of varying crime trends.

RAPE	A homeless man from IL sparked up a conversation with a Chesterfield resident. She invited him over to her apartment. The victim reported a rape occurred. The Detective Bureau, Special Enforcement Unit, and the Reporting Officer collaborated to eventually locate the suspect and arrest him. The St. Louis County Prosecuting Attorney's Office charged him with Rape, Sodomy, and Burglary.
UNLAWFUL USE OF A WEAPON	On 2-20-2024, Officers responded to Toreador Drive in reference to a shot fired call. After a lengthy search, the suspect was arrested. During the original interview by patrol, the suspect denied any involvement in the incident. The Bureau of Criminal Investigations interrogated the suspect the following morning and secured a confession. The subject admitted to being drunk and firing a gun in the residential neighborhood. We responded back to the crime scene with the suspect in custody and located the firearm with the assistance of a canine unit. The suspect was charged with Unlawful Use of a Weapon and Resisting Arrest. Subject was issued a \$75,000 cash only bond.
UNLAWFUL USE OF A WEAPON/ STEALING	Detective Lantz was called in off duty to assist the Patrol Division with a Domestic Assault, Unlawful Use of a Weapon, Stealing Case. He obtained an "Exigent Circumstances" ping on the victim's stolen cell phone and assisted with obtaining a search warrant on subject's vehicle. He also conducted the crime scene processing of the subject's vehicle and located the weapon used in the Unlawful Use of a Weapon.
OF NOTE	Detective Lantz instructed a block of training for HAZMAT during In-Service Training. Detective Muench instructed a block of training on Human Sex Trafficking at two sessions of 1st quarter in-service training.

COMMUNITY AFFAIRS

The Community Affairs Unit is responsible for all crime prevention, police community relations and youth-based programs and initiatives. The unit's programs include Safety Town, COPPS, SRO/ESRO, citizen fingerprinting, speaker's bureau, Neighborhood Watch, child car seat installation program, drug take backs and the citizen police academy. The Department's Volunteers in Policing (VIP) program and the Chesterfield Police Explorer Post are also housed within the Community Affairs Unit.

SCHOOL RESOURCE OFFICERS

The School Resource Unit serves as resources and department liaisons at nineteen public and private schools located in Chesterfield and Clarkson Valley. The agency has ten full time officers assigned to the program. Six of the School Resource Officers (SROs) are individually assigned to the three public high schools and three public middle schools located in the two cities. The high school and middle school SRO programs are partially funded by the Parkway School District and the Rockwood School District representing one of the department's many successful community partnerships. In recent years, the department has added three additional officers to the unit that serve a similar role in the City's elementary schools, the Elementary SRO program (ESRO). These ESROs are assigned to seven public and six private elementary schools. Additionally, one ESRO is assigned to Logan College.



The department's Code Enforcement Inspector works closely with offending property owners to abate the violation(s); however, legal remedies will be sought when those efforts fail. 


PERSONNEL
