


CHESTERFIELD POLICE DEPARTMENT

BUREAU OF UNIFORMED PATROL

The Bureau of Uniformed Patrol is the largest bureau of the department, consisting of three Lieutenants, six Sergeants and thirty-six Police Officers. These officers provide a visible, uniformed presence within the community, 24 hours per day, 365 days per year. The bureau is responsible for responding to all calls for service; to include crimes in progress, crimes discovered, alarms sounding, traffic crashes and hazards, emotionally disturbed persons, and a myriad of other requests for service. In addition, officers perform preventative patrols of neighborhoods, businesses and parks to detect and deter criminal activity, as well as routinely conducting traffic enforcement to improve traffic safety. Several officers assigned to the bureau are cross trained as Crime Scene Officers whose responsibility is to seize evidence and process crime scenes for forensic evidence. A number of Chesterfield officers have received extensive training to be certified as Crisis Intervention Team officers, which enables them to provide acute and follow-up support to those experiencing a mental health crisis.

ASSAULT

A fight broke out at Parkway West High School at an 8th grade graduation. The parents of one of the graduates, who are separated, began arguing. The SRO on scene called for an assist as the father and the mother's boyfriend began fighting. Officers responded along with Officers from Ellisville and Ballwin. The father was determined to be the aggressor and was arrested.

FATAL MOTOR VEHICLE CRASH

S. Woods Mill Road: Officers and EMS responded to a two-vehicle crash. Paramedics pronounced both drivers deceased on the scene. Investigators from the Medical Examiner's Office responded and took custody of the decedents. Accident Reconstructions from the department's traffic unit responded to investigate the collision. The next of kin for both drivers were notified. South Woods Mill Road was closed between Brooking Park and Ladue for several hours. The drivers were both residents of Chesterfield.

OVERDOSE

Olive Blvd / MO 141 HWY: Officers responded to a call regarding a person running or crawling in the middle of the road. Upon arrival, a 38-year-old female was crawling on the raised concrete median near the MO 141 overpass. The female displayed symptoms of CNS (Central Nervous System) stimulant use, including suicidal ideation, dilated pupils, impaired judgment, and panic disorder. She admitted to recently using Fentanyl and crack cocaine. Officers deescalated the situation, handcuffed her, and removed her from the roadway. The female was then transported by ambulance to Mercy, where she was released into their care and custody.

TRAFFIC ENFORCEMENT UNIT

The Bureau of Traffic Enforcement is responsible for the safety of Chesterfield's residents and visitors as they travel throughout the 244 miles of traffic-ways that wind throughout the 32 square miles of Chesterfield. Additionally, the Unit is charged with coordinating enforcement, safety and security for all special events, such as the annual Independence Day celebration, various runs, and other events held within the City. The Traffic Unit maintains primary responsibility for directed traffic enforcement, accident investigation and special event traffic management throughout the City of Chesterfield.

Priority Street Enforcement Activity

The Priority Street Traffic Enforcement program identifies numerous streets throughout the City where enhanced enforcement efforts are conducted. These streets are selected based on crash statistics and/or citizen complaints. The majority of these locations are within subdivisions where complaints of speeding and/or stop sign violations have been received. Officers assigned to the Traffic Enforcement Unit and the Bureau of Uniformed Patrol are expected to routinely monitor these locations and take enforcement action when necessary.

SPECIAL ENFORCEMENT UNIT

STEALING FELONY/CHILD ENDANGERMENT

On two separate days, 4 adults and a teenager stole \$5300 worth of merchandise from Macy's. The subjects were located in a vehicle while fleeing the theft. Subsequent to the car stop, investigators arrested the five subjects and discovered a 6-week-old, 1 year old, and 4-year-old were also in the vehicle and not in car seats. The subjects were charged with multiple counts of Stealing Over \$750 and Child Endangerment.

STEALING 4TH OFFENSE

SEU arrested a subject at Premium Outlet for stealing from 4 separate businesses. A review of the subject's criminal history revealed numerous convictions for stealing related offenses. The subject was charged with Stealing 4th Offense.

FELONY STEALING

Two females stole a felony amount of merchandise from Dick's Sporting Goods. One subject was apprehended on scene and the other fled in a vehicle. The subject who fled, was later apprehended and both charged with Stealing Over \$750 and resisting arrest.

OF NOTE:

Perfect Game continued their season at CVAC this month. Required patrols of the facility have begun during the weekends with the assistance of officers from Community Affairs.

CLARKSON VALLEY

On June 1, 2017 the department entered into a contractual agreement with the neighboring City of Clarkson Valley to provide comprehensive police services; 24-hour uniform patrols, traffic enforcement, response to calls for service, court and meeting security and community engagement programs.

BUREAU OF CRIMINAL INVESTIGATIONS

The Bureau of Criminal Investigations is responsible for the follow-up investigation of all active offenses. The Bureau has one detective assigned to all juvenile cases and one detective detached to the St. Louis County Drug Task Force. The Unit is also responsible for major crime scene management, electronic forensic examinations, intelligence information management and personnel background investigations. The Bureau of Criminal Investigations also houses the Crime Suppression Unit which is responsible for the investigation and suppression of varying crime trends.

BUREAU OF CRIMINAL INVESTIGATIONS

STEALING A MOTOR VEHICLE

Three subjects went to Echo Park and one of them pretended to be interested in purchasing a BMW in order to take the vehicle on a test drive. The other two responded to a nearby gas station to take custody of the vehicle so the original subject could report it as stolen. One subject was arrested that day. The BMW was located/recovered and returned to the owner the next day. The second subject was convinced to respond to the station and turned himself in with his attorney. After an interview with detectives, the subject was arrested for Stealing a Motor Vehicle. The 3rd subject is still being sought after.

PROSTITUTION

A search warrant was served in concert with St. Louis County PD Special Investigation Unit on Sunny's Massage at 13714 Olive Blvd. leading to 2 Prostitution arrests with State charges and over \$8000 was seized.

SEX OFFENDER

During the investigation of an alleged assault occurring during a middle school basketball game, it was determined the coach for one of the teams is a Tier 3 Sex Offender who is prohibited from coaching youth teams. The subject cooperated with the investigation and turned himself in for processing.

OF NOTE:

The Detective Bureau completed 6 background investigations of applicants (4 Police Officer, 1 Code Enforcement Officer, 1 Records Clerk).

COMMUNITY AFFAIRS

The Community Affairs Unit is responsible for all crime prevention, police community relations and youth-based programs and initiatives. The unit's programs include Safety Town, COPPS, SRO/ESRO, citizen fingerprinting, speaker's bureau, Neighborhood Watch, child car seat installation program, drug take backs and the citizen police academy. The Department's Volunteers in Policing (VIP) program and the Chesterfield Police Explorer Post are also housed within the Community Affairs Unit.

SCHOOL RESOURCE OFFICERS

The School Resource Unit serves as resources and department liaisons at nineteen public and private schools located in Chesterfield and Clarkson Valley. The agency has ten full time officers assigned to the program. Six of the School Resource Officers (SROs) are individually assigned to the three public high schools and three public middle schools located in the two cities. The high school and middle school SRO programs are partially funded by the Parkway School District and the Rockwood School District representing one of the department's many successful community partnerships. In recent years, the department has added three additional officers to the unit that serve a similar role in the City's elementary schools, the Elementary SRO program (ESRO). These ESROs are assigned to seven public and six private elementary schools. Additionally, one ESRO is assigned to Logan College.

- ⇒ Two additional job offers were extended by the Chief and were immediately accepted. These included a recent graduate of the Southeast Missouri State University Police Academy as well as a current attendee of the Eastern Missouri Police Academy who is scheduled to graduate in July 2024.
