Every individual, partnership, association or corporation who sells, deals or offers for sale goods, wares, merchandise or articles of food in the City of Chesterfield shall procure from the City Clerk a license and shall pay a license fee of <u>twenty-five (\$25.00) dollars per sales event</u> (not to exceed twenty-eight (28) calendar days). <u>A maximum of three (3) permits per year shall be issued to any person, firm or organization</u>. Charitable organizations are exempt from fee.

It is understood that if a license is granted it must not be used or represented in any way as an endorsement by the City of Chesterfield.

## Itinerant merchants must display the license while conducting business.
