Wild Horse Creek Road Realignment Nears Completion

he St. Louis County Highways and Traffic Division reports that the realignment of Wild Horse Creek Road is scheduled to be completed by November. Having experienced no weather or construction delays, the project will be ready to open on schedule. The realignment begins at Baxter Road and continues west where it will now tie in at Old Chesterfield Airport Road, near the eastbound I-64 off-ramp and the Shaw Office Building. The temporary lights that have been



installed at Baxter and Chesterfield Airport Road will be removed once the new extension is opened, and access to Old Town Chesterfield will remain open. No new traffic signals are planned along Wild Horse Creek Road at this time.

This \$3.6 million road improvement project has been made possible through two mechanisms. Sachs Properties donated the engineering design work and the right-of-way property required. The construction costs were funded from a voter-approved Transportation Development District (TDD) sales tax of 3/8 cent on retail sales made in the Chesterfield Valley. More improvements are forthcoming, as promised, from the TDD. Read more about these in the letter from the Mayor.

Additionally, the Missouri Department of Transportation is resurfacing Wild Horse Creek Road and has a required completion date of November 15.

Update on Public Projects around Town

hope you all had a very enjoyable summer and I'm sure this finds you preparing for a fall season full of activities and getting back into the swing of routines. As we have become accustomed, summer is the season for road construction and we are once again navigating the myriad of projects designed to improve our neighborhoods and our daily commutes. In Chesterfield, you see the proliferation of our Public Works Department in neighborhoods improving streets and sidewalks, which can be an inconvenience, I know, but is a necessity for the quality of our neighborhoods.

Wild Horse Creek Road Improvements

As I attend subdivision and other civic group meetings, I am repeatedly asked about a couple of projects involving Wild Horse Creek Road (WHCR). First, I'm proud to say that the reconstruction of WHRC from Baxter Road to the Chesterfield Parkway is on schedule to be completed by November (see related story on front page.) I understand the normal commute disruption this project has caused, but long-term it will provide a better and safer commute for the thousands who travel this area. This is the first project made possible through the Transportation Development District (TDD), which the voters overwhelmingly approved in the fall of 2005. The TDD's &-cent sales tax on retail purchases within Chesterfield Valley will ultimately fund over \$25 million in public improvements to alleviate the traffic effects incidental to the development of Chesterfield Valley.

The second WHCR project generating much comment is the proposed reconstruction and realignment of the intersections of Long Road, Kehrs Mill Road (both county roads) and WHCR (state road). When completed, this project will have several important components: it will relieve traffic backups and congestion which currently make this area what I call the biggest traffic disaster in the City; it will provide for pedestrian access from neighborhoods off WHCR and Kehrs Mill Road to Chesterfield Valley and the pathway to be constructed on top of the levee; and it will improve the appearance of the entrance onto Kehrs Mill Road from WHCR. The project is made possible due to a great deal of coordination and cooperation by the City, MoDOT, St. Louis County, Monarch-Chesterfield Levee District, Army Corps of Engineers (because of the creeks), and TDD Board, which is comprised of County Executive Charlie Dooley, County Chief Operations Officer Garry Earls, Chesterfield City Administrator Mike Herring and me. This project is a great example of how we use the success of our business centers and the power of our partnerships to improve your quality of life. Plans are being carefully finalized and we anticipate that construction will begin in the spring of 2008.

Levee Trail System

I am very pleased to report that construction is underway on the first portion of the levee trail system along the Monarch-Chesterfield Levee in Chesterfield Valley. The first phase of the project will begin on the north side of I-64 at the Summit Ice Complex to the east and connect to the Chesterfield Valley Athletic Complex to the west, allowing you to use any type of non-motorized transportation along the trail. Eventually, the trail will completely encircle the entire Valley, with future connections northward to the Great Rivers Greenway trails system along the Missouri River (with a



connection to the Katy Trail via the Page Avenue Bridge) and the Mississippi River. Ultimately, there will be connections to the south through Wildwood and the Meramec Greenway. Also, the pathway on the levee will be connected to the Pathway on the Parkway around the center part of the City, which in-turn provides connections to the neighborhoods.

2008-A Reason to Celebrate

In addition to these completed and ongoing transportation and trail enhancements, the coming year will provide the citizens of Chesterfield with many reasons to celebrate. I'm proud to officially announce that all of the Chesterfield Valley Tax Increment Financing (TIF) debt issued following the flood of 1993 will be paid in-full early in 2008! These bonds and other instruments were issued to fund a variety of public infrastructure improvements in the Chesterfield Valley, including the Boone's Crossing highway interchange, enhancements to the Monarch-Chesterfield Levee to improve flood protection in the Valley, the construction of Edison Avenue from Long Road to Baxter Road, as well as water, sewer and drainage infrastructure improvements throughout the Valley. The tremendous success of the TIF district and the consequent investment by the hundreds of businesses now located in the Valley has allowed this debt to be retired nine years ahead of schedule! I am proud of the fact that the TIF district, which I was once Chairman of prior to being elected Mayor, is now widely regarded as one of the most successful TIF districts in the United States.

Also in 2008, we will commemorate the twentieth anniversary of the founding of the City of Chesterfield. We are in the early stages of planning and I welcome your ideas and input so that the official events are worthy of the milestone. Chesterfield is a great community because so many of you have donated so much of your time and energies over the years to make it so, which is why I call Chesterfield the "City of Volunteers". 

aper bags are better than plastic, right? Neither is better! They both gobble up natural resources and cause significant pollution. Here are some interesting facts:

- It takes four times more energy to manufacture a paper bag as it does to manufacture a plastic bag. Plastic bags are made of polyethylene, a petroleum product which is a nonrenewable resource. Four to five trillion plastic bags are manufactured each year of which 100 billion are thrown away; only 1% is recycled.
- Forests (major absorbers of greenhouse gases) have to be cut and the subsequent manufacturing of paper bags produces greenhouse gases.
- Paper sacks generate 70% more air pollutants and 50 times more water pollutants than plastic bags when manufactured.
- It takes 91% less energy to recycle a pound of plastic than it takes to recycle a pound of paper. Plastic bags choke landfills. Recycling rates of bags are extremely low with only 10-15% of paper bags and 1-3% of plastic bags. Littered plastic bags are carried by the wind into forests, ponds, rivers and lakes; some animals mistake these plastics as food and suffer extreme consequences.

The sustainable shopping choices are to:

- Reduce waste: opt to not use paper/plastic bags and choose reusable canvas or cloth bags or totes. Store them in your car.
- Reuse all bags if you have no choice.
- Recycle plastic and paper bags. Most grocers accept plastic and paper bags for recycling, and paper bags are taken for recycling curbside and in our Annual Recycle Drives. Some grocers sell reusable bags, too.

Community Emergency Response Teams (CERT)

Starting September 19th, the Chesterfield Police Department and Monarch Fire Protection District will co-host another 24hour Community Emergency Response Team (CERT) training program.

The CERT program provides an effective first-responder capability with the aid of citizen involvement. Acting as individuals or in teams during a disaster, trained CERT volunteers can fan out within a particular neighborhood or business complex extinguishing small fires, performing light search and rescue and rendering basic first aid for disaster victims.

Individual civilian volunteers will be recruited and trained as neighborhood, business, and government teams that, in essence, will be auxiliary first responders. These groups can provide immediate assistance to victims in their area, organize spontaneous volunteers who have not had the training, and collect disaster intelligence that will assist professional responders with prioritization and allocation of resources following a disaster.

CERT is about readiness, people helping people, rescuer safety, and doing the greatest good for the greatest number. Through training, citizens can manage utilities, put out small fires, provide basic medical aid and save the lives of neighbors or coworkers.

CERT is a positive and realistic approach to emergency and disaster situations where citizens can make a difference.

BIKE SAFETY DOESN'T HAVE TO BE ALL UPHILL!!!

opefully, as a parent, you wouldn't dream of letting your child ride in the front seat of your family car without a seat belt. Would you let them jog along a busy interstate? Would you let them in the deep end of the pool if they didn't know how to swim? How about riding a bicycle without a helmet?

Most people don't associate riding a bike without a helmet as being as dangerous as these other activities, but in 2004 there were 725 fatalities from bicycling and over 48,000 traffic related injuries! Every year more than 300,000 children under the age of 14 are treated in emergency rooms for bicycle related injuries. It is estimated that universal bicycle helmet use by children ages 4 to 15 would reduce these injuries by over 100,000!

So how difficult would it be to convince your child that bike helmets are cool? Not difficult at all. The key to bike safety is to have your child realize at an early age that bike riding is fun, but it cannot be done without a helmet. Parents should model good behavior right from the start. On family bike rides make sure that all the members of the family have helmets on for their safety. Explain, just as a seatbelt can save lives, so too can the simple task of wearing a helmet.

Positive examples can be found in many places. The professional bicyclists wear helmets for all their races. The really cool BMX racers have theirs on too. You can point out that even the police officers who ride their bikes to protect the public wear helmets.

Chesterfield Awards 2nd Annual Ancient History Award to Parkway Teacher

Parkway teacher Michelle Weissenborn was presented with the second annual "Chesterfield Ancient History–Leonard Blake Award" at the May 21, 2007 meeting of the Chesterfield City Council.

The award is named for Missouri's preeminent amateur archaeologist, Leonard Blake. The late Dr. Blake's documentation of prehistoric Native American archaeological sites in the area, in the 1940s, led to a large swath of Chesterfield being placed on the National Register of Historic Places, as the Bonhomme Creek Archaeological District.

The award recognizes individuals and organizations that have made significant contributions toward our better understanding of the various ancient cultures that have flourished in Chesterfield for over 10,000 years.

Michelle Weissenborn was recognized for her ongoing efforts to ensure that children growing up in our area will possess a deeper appreciation of Chesterfield's ancient past.
