Chesterfield marches on through economic downturn

In a world full of uncertainties and apprehension, especially given the challenges we have all faced during this prolonged economic downturn, I'd like to take this opportunity to assure you that your City is on sound financial ground.

Similar to all other government organizations across the nation, we too have had to face the realities of decreased revenues. Unlike many other municipalities, however, Chesterfield does not collect a property tax (other than three cents which we are required to spend on debt service, for a previous Parks bond issue). We are very dependent upon sales tax revenues, which are directly linked to consumer confidence.

The Missouri Legislature forces us to be a "pool" city. This prohibits us from keeping all the sales tax collected in Chesterfield. Instead, that money goes into the County pool. Thus, our income is significantly lowered. Further, even though sales tax collections in Chesterfield are not down as much as they are in other areas of the County pool, we see only the overall effect.

In 2010, we faced these challenges and made some tough decisions, while also trimming expenditures in all areas of the organization. Our staff accomplished this, while delivering on our commitment to maintain service levels. The current budget includes no increases in any taxes or fees. Our fund reserves, or emergency funds, remain strong and, as required by policy, are still

above 40% of our general fund balance.

Through careful planning and budgeting, numerous capital projects will be delivered to you in 2011, improving our overall quality of life, while maintaining property values. The decision to purchase and own property in Chesterfield has never paid a higher dividend. Our total assessed valuation, for example, is more than \$1.87 billion, which is the highest of all cities in St. Louis County.

In this newsletter issue, you'll read about exciting improvements to Central Park that include the opening of a world-class amphitheater, trail systems and stream walks that will be unveiled during a grand opening celebration, planned for everyone to enjoy, on May 21.

Additionally, there are new concession areas and fields at the Chesterfield Valley Athletic Complex and additions to the Monarch-Chesterfield Levee Trail. All of these were improvements promised and delivered to you through grant funds or as part of "Proposition P," the half-cent sales tax for parks that you passed in 2004.

We are moving forward with several street repair and replacement projects this year that will further enhance your property values and neighborhoods. You might be interested in knowing that, over the years, we have spent an average of \$2 million annually on public infrastructure within our community.

While we have always known what a great

community we live in, others continue to take notice! We received the 2011 Creative Community Award from the Missouri Arts Council, due to our partnerships with Chesterfield Arts and other agencies in the community that allow us to provide a diverse offering of both visual and performing art forms. Additionally, *Missouri Life* magazine has named us a Top Ten Town in Missouri, recognizing several aspects of our community including our outstanding schools, shopping and dining options, police protection, tourism activities and health care availability, among other criteria.

Citizen volunteers continue to provide assistance to our City in many ways, enhancing quality of life. For example, the Chesterfield Historical Commission will soon be offering a book on the history of Chesterfield, describing our area from early Native American villages to present.

I am proud and honored to be serving as your Acting Mayor, and I look forward to working with the new Mayor and City Councilmembers when they are elected on April 5. I encourage you to become familiar with the candidates and vote for the next slate of dedicated leaders for this wonderful community of Chesterfield!

Chesterfield wins praise from Mo. Arts Council, magazine

The Missouri Arts Council (MAC) has announced its selection of 2011 Arts Awards recipients. The Missouri Arts Award honors individuals and organizations that have made profound and lasting contributions to the cultural and artistic climate of the state.

Chesterfield is the only municipality to be honored (see box at right). Stacey Morse, Executive Director of Chesterfield Arts, nominated the City for the award.

Meanwhile, *Missouri Life* magazine compared Missouri cities with populations between 2,500 and 50,000. The first round of ranking looked at a town's unemployment ranking, violent and property crime rankings, and education statistics. From these, the top 30 advanced to a second round of measurements.

Round two measured a town's quality of life, for which the magazine looked at both amenities available to residents (bookstores, restaurants, public libraries, movie theaters, performing arts, parks, trails, and religious denominations) and town attributes (recycling, green energy, sales tax, household income, and air quality).

Safety Town gives preschoolers a dose of street smarts ...



Safety Town gives preschoolers valuable lessons on street safety. The two-week sessions run from June 6-July 22.

afety Town is a nationally recognized preschool safety program which teaches children ages 4-6 about a wide variety of safety issues, including bicycle safety, water safety, school bus safety, and stranger danger.

The program includes classroom activities as well as

outside hands-on activities in the miniature Safety Town city.

The program is hosted & staffed by the Chesterfield Police Department in cooperation with the Chesterfield Rotary, the Chesterfield Kiwanis and the Parkway School District. The program is conducted for six, two-week sessions during the summer months.

Safety Town is one of the department's most popular programs. In addition to commissioned police officers, the Safety Town staff includes teen counselors from area middle and senior high schools who assist the police officers in leading the program. All Safety Town sessions will be held at the Chesterfield Day School, 1100 White Road, Chesterfield.

... while AARP classroom program sharpens driving skills of older drivers

The next edition of the AARP Driver Safety Program is scheduled April 12 from 9 a.m.-1 p.m. at City Hall.

The program is conducted by the Chesterfield Police Department in cooperation with the American Association of Retired Persons.

The AARP program is the nation's first and largest classroom driver improvement course.

It reviews the rules of the road with an emphasis on defensive driving practices. The four-hour course is taught in a single morning session and does not involve a test. Fee is \$12 for AARP members, \$14 for nonmembers.

Baxter Road will close at Edison for flood gate work

Baxter Road will close at Edison Avenue for seven days at the end of March.

The shutdown is necessary as the Army Corps of Engineers works on the flood wall at the intersection. Baxter Road is scheduled for a seven-day closure starting March 28, while the contractor drives pilings across the road for the construction of a flood gate. During this time, traffic detours and signage will direct travelers.

Later this year, Baxter Road will be closed at this location again, for



up to 45 days, while the contractor completes placement of the gate and reconstructs the roadway. Notices will be posted prior to both closures.

Fleet maintenance software provides efficiency to City

The City has more than 350 vehicles and pieces of equipment that are used every day by various departments to provide the highest level of municipal services to the community.

These include police cars, dump trucks, snow plows, construction equipment, pruning saws, edge trimmers, mowers and field groomers, to name a few. All are maintained by the Fleet Maintenance Division of the Planning and Public Works Department.

In 2010, the fleet maintenance software was upgraded, allowing the Fleet Maintenance Division to schedule and track all repairs; schedule preventative maintenance; inventory parts; and track fuel usage, registrations and permits. The Fleet Maintenance Division will use this new software to reach the ultimate goal of maintaining a reliable and safe fleet of vehicles and equipment in the most efficient and cost effective manner possible.

Applications accepted for residential sanitary sewer program

Are you experiencing a problem with your sanitary sewer lateral? If the answer is yes, then you may be eligible to participate in the Residential Sanitary Sewer Lateral Repair Program. The program will cover the cost of

certain repairs to a maximum of \$15,000.

The program application and policy/procedures document can be obtained at City Hall from 8:30 a.m. to 5 p.m. Monday through Friday. These documents can also

be accessed online at the City's website, www.chesterfield.mo.us.

Next phase of construction on Levee Trail will begin soon

Construction of the next phase of the Monarch-Chesterfield Levee Trail begins this spring. This phase will add approximately 1.6 miles to the trail and extend it from just north of the Howell Island Access to Centaur Road.

The City has partnered with

the Missouri Department of Conservation to construct a trailhead at the Howell Island Access as part of this phase. The trail will eventually be 17 miles long and encircle Chesterfield Valley.

Design and easement

acquisition is continuing on future phases. The trail is a partnership among the City, the Monarch-Chesterfield Levee District, the Chesterfield Valley TDD, and the Great Rivers Greenway District. It will be a key component of the Missouri River Greenway.

Slab replacement, new road connection head list of City projects

The City will replace 32,000 square yards of concrete slabs on 11 residential streets this year as part of the Concrete Slab Replacement Program. Residents adjacent to the planned replacement areas, along with subdivision trustees, will be notified by mail. The streets scheduled for slab replacement:

- Strawbridge Drive Meadowbrook Way Drive • Saylesville Drive
- Strollways Drive Justus Post Road Shadyford Court Judson Manor
- Woodlet Park Court Conway Road
- Baxter Forest Ridge Court Carriage Crossing Lane

Slab replacement will begin in May

and extend into the fall.

Lydia Hill Drive Extension:

City Council has authorized the extension of Lydia Hill Drive, which will connect with August Hill Drive and provide a direct connection between Chesterfield Parkway West and Baxter Road. The project consists of approximately 1,600 feet of roadway. The sidewalks located along the extension will also serve as access points to the Riparian Trail, the first phase of which is under construction.

Appalachian Trail Phase I

– Road Reconstruction: The City received a Federal grant to assist in the 2012 reconstruction of Appalachian

Trail between Olive Boulevard and Beaver Creek Road. The City will award a contract for design this year. The improvements will include new concrete, new vertical curbs, and updates to the storm water system.

No additional right of way is anticipated to be required.

Schoettler Valley/Country Ridge Bike Route:

As part of the Chesterfield Bikeable Walkable Community Plan, the City will designate a 3.6-mile bike route from Clarkson Road along Country Ridge Drive and Schoettler Valley Drive, ending at Chesterfield Parkway.

Chesterfield's Past

Historical Commission's book traces history of area

A new book tracing the history of the Chesterfield area will soon be available. *Chesterfield, Missouri* from Untamed Wilderness to Thriving Municipality is authored by the Chesterfield Historical Commission.

The Commission's Book Committee, comprised of five core members, worked diligently for six years planning, researching, interviewing and writing this book, with assistance from several contributors.

As the title suggests, the

book describes the lifestyle of Native Americans who called this area home. It also examines the evolution into the dynamic city that Chesterfield is today. Some of the steps described in this evolution include Chesterfield's role in Missouri statehood, Chesterfield's German heritage, the Burkhardt Historic District, the parts played by POWs, Louis Sachs, the Flood of 1993, and the path to incorporation.

Anticipated release of the book is late spring, and it will be available at City Hall for \$30.

City will help with trees in right of way

The Residential Street Tree Program provides for the planting of trees within City right of way (usually the space between the sidewalk and the street) along public residential streets.

In order to qualify for the program, there must be adequate space for a tree as described in the application materials. If adequate space exists, you can submit an application along with a \$100 fee to City Hall. Trees are $2\frac{1}{2}$ -inch caliper and approximately 10 feet tall, depending on species. They are planted twice a year, in spring or fall.

The deadline for receiving a spring tree has passed, but an

application can be sent in anytime before Aug. 31 for fall trees.

One common misconception about the program is that the City will remove any existing trees in the right of way upon receipt of an application for new trees. The City only removes trees that are dead, dying, diseased or hazardous, as determined by qualified City staff after an inspection. To determine if a tree qualifies for removal, contact the City (636.537.4000) and request an inspection *before* submitting an application for a new tree.

If the trees are to be removed, a new-tree application should be sent in *after* removal.
