City Prepares Five-Year Financial Forecast

The City's five-year financial forecast (2023-2027) was presented to the City Council at their June 7, 2022 meeting. This forecast is based upon the detailed line item and account level revenue and expenditure assumptions with currently known or anticipated service levels and associated expenses. The assumptions include no additional headcount in spite of the growth in service obligations. The details of the five-year forecast can be viewed on the City's transparency portal, https://www.chesterfield.mo.us/five-year-forecasts.html.

As background for the forecast, it is important to review revenue and expenditure trends. The City's 2021 revenues increased \$741,603, or 1.9%, since 2014. In 2018, Proposition P generated additional revenue of \$2.6 million annually dedicated to Public Safety. During this same timeframe, expenditures have decreased or remained flat, except for Public Safety (Police Department) that increased \$2.5 million (28.9%).

Therefore, as the City's obligations continue to expand due to development and growth, current service levels will diminish. Based on the stated assumptions, expenses are expected to exceed revenues in 2024 and the General Fund Reserves will dip below the 40% policy in 2027. Staff have been tasked with identifying strategies to address the issue of expenses outpacing revenues. The five-year forecast will be regularly updated and presented annually.

Mayor's Message

So many new and exciting things going on in Chesterfield!

Many of these things may have previously been written and many of you are already aware, but progress is now visible. There is vertical development taking place in the residential component of Wildhorse Village, where internal roadways with landscaped medians and streetlights are now visible. It is nice to see this first-rate development take shape!

Running along the creek, just west of this development, is the recently completed Riparian Trail addition, Phase II, that extends the original trail from Lydia Hill northward crossing Wildhorse Creek Road and ending at Old Chesterfield Road. This paved trail is available to pedestrians and cyclists.

Macy's recently announced their plans to move from Chesterfield Mall to a smaller location in Chesterfield Commons in the Valley. This move is scheduled to take place in the fall and is an important step toward the eventual redevelopment of Chesterfield Mall.

Another new youth sports venue recently broke ground. The 18,000 square foot indoor Chesterfield Sports Complex features competitive basketball and volleyball and is located off South Eatherton near The Crossing Church.

Perfect Game

In June, the City of Chesterfield was happy to announce a new partnership with Perfect Game. The City has signed a ten-year agreement with the largest baseball/softball tournament organizer in the country. Perfect Game events attract college and professional scouts and will host high skill level tournaments for youth from surrounding states, as well as local teams.

Over time, our local leagues have trended to predominantly weekday league games. This allows them to travel and compete in tournaments

over the weekends. Now, Chesterfield will be the regional hub for major



baseball and softball tournaments. A key component of the agreement is that Chesterfield will install synthetic turf on the infields of 12 additional fields, bringing the total number of turfed infields to 16. This will decrease the number of rainouts and optimize the tournament experience for teams.

Obviously, we are hopeful, and anticipate that the additional out-of-town visitors will be good for local businesses, while contributing to our bottom line. Congratulations to Director Tom McCarthy and Superintendent Kevin Schuh from our Parks Department on negotiating this very important agreement.

Resolution To Establish a TIF Commission

On July 25, the Chesterfield City Council unanimously adopted a resolution to establish a Tax Increment Financing (TIF)

Commission, for the purpose of addressing the public infrastructure needs in and around the Chesterfield Mall and Wildhorse Village.

This is an important step toward the potential redevelopment of what is now known as Chesterfield Mall. A determination that Chesterfield Mall is economically blighted has been made. The TIF Commission is required to review the proposed redevelopment plan and conduct a public hearing, after which they will make a recommendation to the Chesterfield City Council. If a TIF District is ultimately established, here are some basic facts:

- 1. No taxing entity would receive less revenue than current levels.
- 2. The property owners/developers continue to pay the full property tax based on assessed value, even as the assessed value increases with development. There is no tax abatement, no deferrals.
- Only statutorily eligible infrastructure projects could be financed by TIF.
- 4. Creation of a TIF District will result in NO additional consumer taxes for you. No increase in sales tax rates and no new or additional taxes from Chesterfield residents and business. The owners/developers within the TIF District pay their full property tax. Sales tax rates in the TIF remain the same rate as they are currently.
- If a TIF is established, it will be controlled by City of Chesterfield.

6. The City of Chesterfield will not be liable for any of the TIF obligations or payments on TIF projects.


The economic development tool, Tax Increment Financing (TIF), is an important tool for projects such as Chesterfield Mall. However, for some, TIF has a bad reputation. As with any development tool, they can be misused. But the City of Chesterfield has experience and a track record of successfully using the TIF in Chesterfield Valley. The City is vigilant to ensure that TIF is used to fund public improvements and not to subsidize or incentivize private development. When used properly and responsibly, it can be an enormously valuable economic tool that can not only benefit our community, but our entire region. As an example, the Chesterfield Valley TIF that was created after the flood of 1993 was paid off 10 years early and now provides enormous revenues to the school districts and all the taxing entities.

I am sure there will be a lot more information coming out in future months.



All About Roundabouts





Motz/Jacob Families

Frederick (Fritz) Motz (1851-1929) was born in Alsace-Lorraine, France in 1851. Following the defeat of France in the Franco-Prussia War, Fritz emigrated to Meramec Township, Missouri in 1871, where he acquired 80 acres of farmland. He planted peach orchards and raised pigs and cows. He took his fruits and vegetables into St. Louis to sell, while local taverns purchased his pork and beef. Fritz met the George Heinrich (Henry) Jacob family at St. John's Lutheran Church in present day Ellisville. Henry (d. 1896) and Magdalena (1836-1909) Jacob owned 80 acres near Hutchinson Road. On November 28, 1880, Fritz married Henry's daughter Christine.

Fritz and Christine Motz lived on a farm off Valley Road on which they raised their two children: Daniel Albert and Katherine (Katie). While Daniel and Katie were growing up, Fritz would work all day in his fields, then walk into town to purchase tobacco. Daniel Albert (1885-1961) married Martha Schindler (1896-1961), a Texan by birth, in St. John's Lutheran Church on November 6, 1916. They lived on 40 acres on Valley Road across from Daniel's parents, but their holdings grew to 120 acres following the death of Daniel's father. Daniel's sister, Katie, married William (Bill) Eberwein in 1916. They operated a filling station in Ellisville during the 1930s.

Daniel Albert and Martha had six children: Leanoria, who married Norman Eatherton; Albert, who married Mary Messmer; George, who married Elveria Fick; Daniel, who married Geraldine Haus; and Marty, who married Donna Kesslering. Daniel, like his father, was a successful farmer, who also sold his farm products in St. Louis. His early acquisition of a tractor helped with his success.

Daniel and Martha's son, Albert (1921-2012) married Mary Messmer (1925-2014) in St. Louis, but they resided on Clayton Road near Hutchinson and Valley Roads. They are buried in St. John's Lutheran Church Cemetery in Ellisville. Albert and Mary had a son, Richard (b. 1953), who married Anita Cole (b.1954) at St. John's Church in 1981. They have two children: Jennifer (Jen) (b. 1985) and Richard, Jr. (b.1987). Richard, Sr. is a retired carpenter.

Street Solicitation in Chesterfield

From time-to-time, street beggars may be seen standing at or near street corners in Chesterfield soliciting for money. While often well intentioned, such activity creates traffic safety concerns. Drivers attempting to read handheld signs or trying to communicate in some fashion are distracted from safe driving practices and may trigger traffic congestion. At the March 21, 2022 City Council meeting, members of the Council adopted an ordinance which prohibits street solicitation of any kind within the City of Chesterfield. With the adoption of this ordinance, the Police Department now has the ability to enforce and resolve such occurrences. Should you observe a street solicitor, we ask that you first refrain from donating to the solicitor and secondly, notify the Police Department so that an officer may contact the person, enforce the ordinance, and offer additional assistance.

Conservation Federation of Missouri Article **Recognizes Chesterfield**

At the request of the Conservation Federation of Missouri (CFM), the Chesterfield Citizens Environmental Advisory Committee (CCEAC) submitted an article about the First Baptist Church of Chesterfield's (FBCC) butterfly pollinator garden. The article was published in the CCEAC's March issue of their state-wide magazine. The article titled, "A Template for Conservation During a Pandemic", describes the origin of the garden and the many partners and volunteers who helped make the garden possible. All materials utilized in the garden were donated by CCEAC, FBCC, and its partners who maintain their National Wildlife Federation (NWF)-Certified habitat garden now! This garden contributed a quality nature garden component to the annual NWF re-certification report of our community, which is now in its 18th year of improving quality nature here. Congratulations to the First Baptist Church of Chesterfield and the City of Chesterfield!

Litter Violations

Please remember that it is a violation of City Code to litter or dump material of any kind on City Streets, in City Parks, or in any stream. City maintenance staff spend time each day picking up litter from City property. All litter which is not removed eventually finds its way, typically via storm sewers, to a City stream. Litter is not only unsightly, but it can be harmful to creek vegetation and aquatic life.

Driveway Apron Snow Removal Program

The City of Chesterfield's Driveway Apron Snow Removal Program offers removal of approximately 10 feet of the windrow of snow (enough space to allow for a vehicle to enter/exit a driveway) which accumulates at the end of your driveway when the City clears snow from public streets.

In order to qualify for this program, Chesterfield residents must live in a single-family residential home accessed via a public street, and have a diagnosed medical condition preventing them from removing snow from their driveway. To request this service, residents must complete three forms: Participant Information Form, Physician Confirmation Form, and Participant Release Form, which are each available on the City's website, https://www.chesterfield.mo.us/ resident-windrow-program.html.

Applications must be received at least two weeks prior to a snow storm to allow for application review and processing. If you have previously registered for this program there is no need to reapply.

The City of Chesterfield will begin driveway apron snow removal operations ONLY after completion of all snow and ice removal operations on public streets and at City facilities. The Driveway Apron Snow Removal Program will only be implemented if snow accumulation exceeds two inches during any single snow event.

Please note that the intent of this program is not to remove snow from your entire driveway. City staff will only remove a strip of the windrow, approximately 10

feet wide, to allow entrance to and exit from your driveway. If you own a driveway with multiple accesses to the City street, the City will only provide this service on one driveway apron.





Public Right of Way

The area immediately adjacent to the street, including the area between the curb and the sidewalk, is generally considered public right of way. The adjacent property owner is responsible for the maintenance of this area, including cutting the grass. However, there are many public amenities, including street signs and street trees, located within the public right of way. Any construction or physical disturbances within the public right of way, including sprinkler systems, invisible fences, the planting or removal of trees, and driveway replacements, require a permit from the Public Works Department. If a street does not contain sidewalk, the public right of way is typically considered the area within 12 feet of the back of the curb. Movable objects should not be kept in the public right of way, including basketball goals and decorative landscape boulders.

You may have recently seen or experienced utility work in the public right of way. Utility companies, including water, sewer, gas, electric, and internet providers are allowed to construct and maintain facilities within the public right of way in accordance with state law. The City does require these utility providers to obtain a permit, which ensures any disturbance within the public right of way is restored to City specifications.

Please note that in many cases utility companies perform work within private easements. A private easement is a property right granted to the utility by a private property owner. An easement on your property may have been granted by a prior property owner or by the developer as part of the platting of your subdivision. The City of Chesterfield has no control over utility work performed in a private easement. If you are experiencing a problem with a utility company working within an easement on your property, the best thing you can do is search your records to determine the location and verbiage of the easement. Then contact the utility provider directly to address any concerns.

Did You Know?

Like most cities, the City of Chesterfield does not install speed bumps.

Speed bumps are effective at slowing traffic in the immediate vicinity of a speed bump; however, they are ineffective at reducing overall speed and cause a number of maintenance problems. Additionally, their use is opposed by emergency response personnel, including police and fire.

Water Quality in the City

Did you know that to permit grading and land disturbance activities, the City of Chesterfield, along with 58 other municipalities, St. Louis County, and Metropolitan Sewer District (MSD), operate under a Municipal Separate Storm Sewer System (MS4) permit from the Missouri Department of Natural Resources? Permit requirements cover a wide range of topics which impact water quality, including posting pet waste disposal signs, ensuring that development sites contain proper silt and erosion control, and bi-annual street sweeping. Additionally, the City must operate its facilities in such a manner to minimize exposure to storm water and train its personnel annually in proper water quality practices.

If you are wondering what you can do to maintain water quality, please remember that all storm water inlets drain to creeks and streams. Please ensure that no trash, debris, or chemicals are washed or dumped into storm water inlets. Additionally, if you are planning a grading project, please contact the City to determine whether a permit is necessary.

City of Chesterfield Financial Funds & Awards

The City of Chesterfield received their 31st consecutive Distinguished Budget **Presentation Award** from the Government Finance Officers Association. The award represents a significant achievement by the City's Finance Department. Each year the City prepares an annual budget, conducts multiple budget workshops, and hosts a public hearing prior to adoption of the budget. This award reflects the commitment of the Mayor, City Council, and Staff to meet the highest principles of governmental budgeting and ensuring the public trust.
