Limit your letter of interest to no more than five (5) pages. This letter should include any information which might help us in the selection process, such as the persons or team you would assign to the project, the backgrounds of those individuals, and other similar projects your company has recently completed or are now active.

It is required that your firm's Statement of Qualification (RsMO 8.285 through 8.291), an Affidavit of Compliance with the federal work authorization program, and a copy of your firm's E-Verify Memorandum of Understanding (15 CSR 60-15.020) be submitted with your firm's Letter of Interest or be on file with the City of Chesterfield. These documents will not be included in the total page count.

DBE firms must be listed in the MRCC DBE Directory located on MoDOT's website at www.modot.org in order to be counted as participation towards an established DBE Goal. We encourage DBE firms to submit letters of interest as prime consultants for any project they feel can be managed by their firm.

It is required that your firm be prequalified with MoDOT and listed in [MoDOT's Approved Consultant Prequalification List](#), or your firm will be considered non-responsive.
