## RESOLUTION NO. 465

A RESOLUTION DECLARING IMPROVEMENTS OF THE BRANDYWINE NEIGHBORHOOD IMPROVEMENT DISTRICT COMPLETE; AUTHORIZING THE LEVY OF SPECIAL ASSESSMENTS UPON BENEFITTED PROPERTY IN SAID DISTRICT; PROVIDING FOR THE TERMS AND CONDITIONS OF SAID SPECIAL ASSESSMENTS; AND OTHER ACTIONS IN CONNECTION THEREWITH.

WHEREAS, the City of Chesterfield, Missouri (the "City") is authorized and empowered pursuant to the Neighborhood Improvement District Act, Sections 67.453 to 67.475 of the Revised Statutes of Missouri, as amended (the "NID Act"), to establish a neighborhood improvement district ("NID") when a proper petition has been signed by the owners of record of at least two-thirds by area of all real property located within the proposed District and filed with the City Clerk; and

WHEREAS, such a proper petition was filed with the City Clerk of Chesterfield, Missouri on September 16, 2019 (the "Petition"), pursuant to the NID Act, proposing the creation of the Brandywine Neighborhood Improvement District (the "District"), described in more detail in the Petition; and

WHEREAS, the City Council of the City reviewed the Petition proposing the creation of the District for the purpose of funding the replacement of streets and parking areas within the boundaries of the proposed District and carrying out the Brandywine Neighborhood Improvement District project (the "Improvements"); and

WHEREAS, on March 2, 2020, pursuant to Resolution No. 458, the City Council established the District, determined the cost of the Improvements at an estimated \$1,090,000.00, ordered plans and specifications for the Improvements be prepared, ordered a proposed assessment roll be prepared, and ordered that said plans and specifications and assessment roll be filed with City Clerk and made open for public inspection and considered at a Public Hearing on March 16, 2020; and

WHEREAS, plans and specifications for the Improvements, including the estimated cost of \$1,090,000.00, and the assessment roll were prepared by the City, and made open for public inspection at a duly noticed public hearing before the City Council on March 16, 2020; and

WHEREAS, following the public hearing on March 16, 2020, pursuant to Resolution No. 459, the plans and specifications for the Improvements were determined to be final and complete, the officers, agents, and employees of the City were authorized and directed to take such further action and execute such other documents, certificates, and instruments to carry out and comply with intent of the Resolution, the Assessment Roll was accepted, the City was authorized to provide funding to finance the costs of the Improvements, and, upon completion of the Improvements, assess the final costs of the Improvements against property described in the Assessment Roll.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHESTERFIELD, AS FOLLOWS:

- <u>Section 1</u>. <u>Completion of Improvements.</u> The Improvements have been completed in accordance with the approved plans and specifications. The final cost of the portion of said Improvements and related costs to be paid by special assessment shall be \$1,008,298.35 which does not exceed the estimated cost of the Improvements of \$1,090,000 as authorized by Resolution No. 459.
- Section 2. Assessment of Costs of Project. The final costs for the project are outlined in Exhibit A, attached hereto and incorporated by reference. The cost of the Improvements shall be assessed as set forth in Exhibit A against each property located within the District in accordance with the final Assessment Roll set forth in Exhibit B, attached hereto and incorporated herein by reference.
- Section 3. Notice of Assessment. Upon approval of this Resolution, the Finance Director shall mail a notice in substantially the form of Exhibit C, attached hereto and incorporated herein by reference, to each owner within the District which sets forth a description of each parcel of real property to be assessed which is owned by such owner, the special assessment assigned to such property, and a statement that the owner may pay such assessment in full after the date of approval of this Resolution until January 31, 2021. Otherwise, such owner shall pay such assessment in substantially equal annual installments from November 30, 2021 to November 30, 2040 as provided in Section 4 herein.
- Section 4. Collection of Assessments. The City Clerk, in the same manner and at the same time as other ad valorem taxes are certified, shall certify for a period of 20 years, all of the assessments that have not been paid in full by November 30, 2021 as set forth above, together with the interest rate of 5% per annum and collection fees, late payment fees and penalties, if any, and such amounts so certified shall be levied and collected with the assessment and levy for each year being a potion of the principal amount of the total assessments plus one year's interest on the unpaid assessments at 5% per annum.
- Section 5. Recording. This Resolution including the final Assessment Roll for the Improvements, is authorized and directed to be filed with the City Clerk and Finance Division.
- Section 6. Severability. The sections, paragraphs, sentences, clauses and phrases of this Resolution are severable, and if any section, paragraph, sentence, clause or phrase of this Resolution be declared unconstitutional, ultra vires or void for any reason by a decree of judgement of a court of competent jurisdiction, such judgement or decree shall not affect any of the remaining sections, paragraphs, sentences clauses or phrases of this Resolution.
- <u>Section 7.</u> Further Authorization and Direction. The City shall, and the officers, agents and employees of the City are hereby authorized and directed to take such further action and execute such other documents, certificates and instruments as may be necessary or desirable to carry out and comply with the intent of this Resolution including, but not limited to, preparation of all appropriate legal and financing documents necessary to effect the assessment of the costs of the Improvements.

Property owners within the boundaries of the Brandywine Neighborhood Improvement District shall have the option to pay a one-time fee of \$5,693.64 by January 31, 2021 or they can pay \$391.65 annually for 20 years. Under the annual payment option, payments would be due by November 30, 2021 through November 30, 2040, which would total \$7,833.02, including interest over the 20-year period.
